**Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas.
An Ordinance to be entitled: An Ordinance amending the Faulkner County Personnel
Manual.**

The Faulkner County Personnel Manual of 2015 is hereby amended as follows:

Section 1: The following shall be added to Section XVI. Overtime Compensation on page 16 as paragraph K:

K. Time and a half for the Faulkner County employees will be allowed with the County Judge's, Elected Official's or Department head's approval, regardless of actual hours worked, in the following situations:

1. A disaster, natural or man-made, which requires a full emergency response in the county or a specific department for the duration of the incident;
2. Special grant funded responses and operations (warrant roundups, saturations, etc.); or
3. Any other operation in which the County Judge, Elected Official, Department Head or Governor has declared emergency pay to be warranted, including a disaster declaration.

Employees may not use any type of paid leave to work time and a half.

Section 2: Section XVI. Overtime Compensation shall be renamed as Section XVI. Special Compensation

Section 3: Section XXXIX. Catastrophic Leave Bank section 2 on page 46 shall be amended as follows:

2. An employee becomes a member of the CLB by contributing eight (8) hours of sick time to the bank annually. Eligible employees will be given an opportunity to sign up each year during open enrollment for a plan year effective January 1st of the next year. Additionally, new full-time employees who complete thirty (30) calendar days of continuous service will also be eligible to participate upon the first anniversary of their hire date. These employees will have thirty (30) days immediately following their thirty (30) day anniversary to declare participation by filling out a Catastrophic Leave Bank Election Form by donating eight (8) hours to the CLB. In order to continue participation, the employee will have to contribute an additional eight (8) hours to the CLB during open enrollment. Employees not electing to sign up during the enrollment period will not be

eligible to participate until the following plan year. Upon enrollment in the plan, an employee will automatically be re-enrolled each year unless the employee signs a cancellation form during open enrollment or no longer meets the eligibility criteria as of the first day of the plan year.

A declaration of participation and contribution shall be made on a Catastrophic Leave Bank Election Form distributed and collected by the Human Resource Office. The CLB form is due in the Human Resource Office between December 1st and January 31st each year for employees electing to participate that year. The committee will review such requests on an individual basis.


Employees wanting to donate additional hours of sick time to the CLB can do so throughout the year. Donations must be made in a minimum of four (4) hour increments and require a contribution form to be completed. Once the donation is made, donations cannot be credited back to the donating employee except in instances where a qualifying catastrophic leave request for time is made to the committee and approved.



An Ordinance creating a new public facilities board to operate the Lake Conway Community Wastewater Utility.

BE IT ENACTED BY THE QUORUM COURT OF FAULKNER COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN ORDINANCE CREATING A PUBLIC FACILITIES BOARD PURSUANT TO THE PROVISIONS OF ACT NO. 142 OF THE ACTS OF ARKANSAS OF 1975, AS AMENDED, TO OPERATE WATERWORKS AND SEWER WORKS FACILITIES FOR THE LAKE CONWAY COMMUNITY; PRESCRIBING OTHER MATTERS PERTAINING THERETO; AND DECLARING AN EMERGENCY.

WHEREAS, Act No. 142 of the Acts of Arkansas of 1975, as amended, the "Act," authorizes the Quorum Court of a county to create public facilities boards for various purposes, including the providing of waterworks and/or sewer facilities for the physical and mental health, safety, and physical and economic welfare of the citizens and residents of such county, and

WHEREAS, the Faulkner County Public Facilities Board and the residents of the Lake Conway Community within Faulkner County have determined a need to establish and operate waterworks and/or sewer facilities to provide a safe an sanitary supply of water and/or sewage treatment for the needs of the public within one mile of the perimeter of Lake Conway, and

WHEREAS, the County is authorized by the provisions of the Act to enable the construction and financing of waterworks and/or sewage collection and treatment facilities through the creation of a public facilities board, and

WHEREAS, it is in the best interest of the Court and its citizens and residents to create a public facilities board to operate the Lake Conway Community Wastewater Utility under the Act.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS, THAT:

Section 1: In accordance with and pursuant to the authority conferred by the provisions of the Act, there is hereby created and established a public facilities board, the Lake Conway Community Wastewater Utility Board, with the authority as hereinafter provided to accomplish, finance, contract concerning, and otherwise dispose of and deal with waterworks and/or sewer facilities. The term "waterworks facilities" and "sewer facilities" as used in this Ordinance shall have the meaning set forth in the Act.

Section 2: The name of the Board shall be "Lake Conway Community Wastewater Utility."

Section 3: The initial members of the Board shall consist of five (5) persons, each of whom shall be residents and qualified electors of Faulkner County residing in the County and shall be appointed by the County Judge, after confirmation by the Quorum Court, by order of the County Court for terms of one, two, three, four, and five years, respectively. Each member, so appointed by the County Court, shall take and file with the County Clerk the appropriate oath of office prescribed by the Act. The appointees, duly appointed and confirmed by this document are as follows: Herman Moix (2), Juanita Brannon (3), Carroll Duvall (4), Jaysson Funkhouser (1), and Oscar Gomez (5).

Section 4: The Board is authorized, from time to time, to own, acquire, construct, reconstruct, extend, equip, improve, sell, operate, maintain, lease, and contract concerning, or otherwise dispose of waterworks and/or sewer works facilities only.

Section 5: The Board is authorized to issue revenue bonds from time to time and use the proceeds therefrom as required to provide waterworks and sewer works facilities including the creation of any desired reserve funds for paying the costs of the issuance of such bonds. Any such revenue bonds shall be obligations only of the Board and shall not constitute any indebtedness for which the faith and credit of the County or any of its revenues are pledged, and the principal of and interest on the bonds shall be payable from and secured by a pledge of revenues derived from waterworks and/or sewer facilities financed, in whole or in part, from the bond proceeds and any other sources as authorized by, and in accordance with, provisions of the Act.

Section 6: The Board shall have all the powers provided for in the Act, subject to the limitations of this Ordinance, and shall carry out its duties in accordance with the Act, including

the filing of the annual report required by section 18 of the Act. The Board shall take all appropriate action necessary to comply with the Constitution and laws of the United States of America and the State of Arkansas, including matters related to open and public meetings as provided by Act 93 of 1967, as amended.


Section 7: In the event any portion of this ordinance is declared or adjudged invalid or unconstitutional, such declaration or adjudication shall not affect the remaining portions of this ordinance, which shall remain in full force and effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of this ordinance and the remaining portions of the ordinance shall be executed fully and faithfully.

Section 8: All ordinances of the County or parts thereof in conflict herewith are hereby repealed to the extent of such conflict.

Section 9: It is found and hereby determined that there is an immediate need for providing waterworks and/or sewer works within the Preston Community of Faulkner County, Arkansas as authorized to be provided under the Act, and the providing of financial assistance to encourage the development of such waterworks and/or sewer works facilities, and that the creation of the Board and the exercise of the duties and powers provided in this ordinance are necessary for the preservation of the public peace, health, and safety. Therefore an emergency is declared to exist and this ordinance shall be in full force and effect from and after its passage and approval.





Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas. An Ordinance to be entitled: An Ordinance repealing Ordinance 16-42, amending the Faulkner County Personnel Manual 2015, and declaring an emergency.

WHEREAS, the Department of Labor issued its final ruling regarding overtime compensation in 2016, which will be effective on December 1, 2016; and

WHEREAS, the Faulkner County personnel policy was altered to be in compliance with the law.

WHEREAS, on November 22, 2016, a federal judge issued a preliminary injunction, which blocked the law from taking effect on December 1, 2016.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS:

Section 1: Faulkner County Ordinance 16-42 shall be repealed.

Section 2: Section XVI. Special Compensation paragraph a will be changed to reflect the following:

Any county employee who makes less than \$455 per week (regardless of job duties) is eligible for overtime compensation.

Section 3: EMERGENCY CLAUSE. The adoption of this Ordinance is an emergency, in that a preliminary injunction was ordered, which halted the proposed overtime rule from taking effect and the County must comply so this Ordinance shall be in full force and effect immediately upon its passage and approval.



ORDINANCE 16-47

Be it enacted by the Quorum Court of Faulkner County, State of Arkansas. An Ordinance to be entitled: An appropriation Ordinance to establish the annual operating budget for calendar year 2017.

Section 1: ANNUAL BUDGET ADOPTED BY REFERENCE.

The annual budget for calendar year 2017 identified as "2017 Annual Budget, Faulkner County, Arkansas", dated December 20, 2016 is hereby adopted by reference. A copy of said budget shall be filed in the Office of the County Clerk and shall be available for inspection and copying by any person during normal business hours.

Section 2: NONRESTRICTED EXPENDITURE CATEGORIES.

Expenditures of funds appropriated by this Ordinance shall not be restricted to the line item expenditure codes comprising the four major categories of expenditures - Personal Services, Supplies, Other Services and Charges and Capital Outlays, but shall be restricted to office/departmental expenditures.

Section 3: EXPENDITURE RESTRICTED TO SPECIFIED FUNDS.

No expenditure of appropriated funds shall be made from any fund other than the fund specified in the Ordinance or an amendment thereto.

Section 4: TRANSFERS.

Any transfer of monies between the various funds of the County or between the four major categories of expenditures – Personal Services, Supplies, Other Services and Charges, Capital Outlays – shall be made only with prior approval of the Faulkner County Quorum Court. Provided, however, all transfers budgeted for in the annual budget shall be exempt from the provisions of this section.

Section 5: REPEALER.


All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed. If any provision of this ordinance or the application thereof to any person or circumstance is held to be invalid, such invalidity shall not affect other provisions or application of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared severable.

Section 6: EFFECTIVE DATE.


