**ORDINANCE 23-01**

**(Sponsored by Justice Lachowsky)**

**BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN ORGANIZATIONAL ORDINANCE FOR THE 2023-2024 QUORUM COURT.**

WHEREAS, the term for the new Quorum Court began on January 1, 2023, and an organizational ordinance for the new Quorum Court is needed; and,

WHEREAS, the Quorum Court desires to establish its regular meeting schedule by ordinance pursuant to Arkansas Code Annotated § 14-14-904, and the Court finds that it is in the best interests of the Court to do so.

**NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS, THAT:**

- Article 1: Unless modified by subsequent ordinance, the regular monthly meeting of the Quorum Court shall hereafter be held on the Third (3<sup>rd</sup>) Tuesday at 6:00 p.m. on January, February, March, April, May, June, July, August, October, November and December. Due to the annual Faulkner County Fair Parade, the monthly meeting of the Quorum Court for September will occur on the Third (3<sup>rd</sup>) Thursday at 6:00 p.m.
- Article 2: The regular monthly meetings of the Quorum Court shall be held at the Faulkner County Courthouse, Courtroom A. If Courtroom A is unavailable, the Justices of the Peace will be timely notified of the meeting location by the Secretariat.
- Article 3: The regular monthly meeting of the Budget and Finance Committee shall be held on the Second (2<sup>nd</sup>) Tuesday of every month at 6:00pm. If the Chairperson or a quorum of the Budget & Finance Committee shall deem it necessary, the date and time of the meeting may be changed as needed.
- Article 4: The regular monthly meetings of the Budget and Finance Committee shall be held at the Faulkner County Courthouse, Courtroom A. If Courtroom A is unavailable, the committee members will be timely notified of the meeting location by the Secretariat.

Article 5: The following regular committees are hereby established to serve the Faulkner County Quorum Court: Budget & Finance, Infrastructure, Courts and Public Safety, and Personnel. Each regular committee shall comprise of five members.

Each committee shall be tasked with the following legislative responsibilities:

- (a) Budget & Finance. The duties of the Budget & Finance Committee shall include, but not be limited to, the following:
  - 1. Consider and/or recommend proposed budgetary items to be presented to the Quorum Court for consideration and final passage or action; and
  - 2. To submit the following year's budget or amend the existing budget; and
  - 3. Review revenue and expenditure projections; and
  - 4. Assess county government programs and operations and recommend sustainable financing arrangements for priority needs.
- (b) Personnel. The duties of the Personnel Committee shall include, but not be limited to, the following:
  - 1. Consider all requests to create or eliminate county employment positions; and
  - 2. Review pay raise requests to ensure reasonableness; and
  - 3. Develop personnel policies.
- (c) Infrastructure. The duties of the Infrastructure Committee shall include, but not be limited to, the following:
  - 1. Consider and/or recommend proposed infrastructure items to be presented to the Quorum Court for consideration and final passage; and
  - 2. Review proposed infrastructure improvements within the County; and
  - 3. Develop ordinances relating to the County's transportation system, water & sewer systems, and other community projects.
- (d) Courts & Public Safety. The duties of the Courts & Public Safety Committee shall include, but not be limited to, the following:
  - 1. Consider and/or recommend proposed ordinances which pertain to the County's court or public safety systems; and
  - 2. Review proposed improvements within the County's courts and public safety systems; and
  - 3. Develop ordinances relating to the improvement of the County's courts and public safety systems.

Article 6: The Quorum Court and all the Committees thereof shall be procedurally governed by the most current edition of the Democratic Rules of Order and shall include the following procedures:

- (a) The Democratic Rules of Order may not overrule or supersede any state statute regarding the governance of the Quorum Court.
- (b) Agendas for the full Quorum Court and the committees shall be set by the chairperson of each committee, and may be amended by the chairperson or a majority of the members.
- (c) Agendas must be submitted to the Quorum Court Secretariat no later than two business days (excluding holidays observed by the county) at 11:00 a.m. prior to any Quorum Court meeting.
- (d) Proposed items that are submitted after the agenda deadline may be considered at a meeting, but will require a suspension of the rules before the proposed item can be introduced for consideration.

Article 7: The County Civil Attorney is hereby designated as legal counsel for the Quorum Court pursuant to A.C.A. §14-14-902(b).

Article 8: In accordance with A.C.A. §14-14-902, the County Clerk or the Clerk's designee is appointed as Secretariat of this Court. The duties of the Secretariat shall be as stated in A.C.A. §14-14-903(a)(3). The County Clerk or the Clerk's designee shall record all full court and committee meetings, with the exception of executive sessions.

Article 9: SPECIAL MEETINGS.


- (a) The county judge or a majority of the Quorum Court members may call a special meeting upon at least twenty-four (24) hours' notice. Such notice shall include the time, date, place, and subject of the meeting. Only the business stated in the notice of the call of the special meeting shall be considered at the meeting.
- (b) If notice of a special meeting is given at any regular or special Quorum Court meeting, it shall constitute due notice to the members present. The Secretariat shall be responsible for notifying those members who are absent.


Article 10: It is hereby recognized that immediate establishment of dates, times, and locations of the regular meetings of the Quorum Court and the Budget and Finance Committee thereof is necessary and is required by state law. Therefore, an emergency is declared to exist, and this Ordinance being necessary for preservation and protection of the public health, safety, and welfare of Faulkner County, this Ordinance shall be in force and take effect upon passage and publication.

Article 11: SEVERABILITY. If any part of this Ordinance is held invalid, such invalidity shall not affect any other portion of this Ordinance.

Article 12: REPEALER. All laws and parts of laws in conflict with this Ordinance are hereby repealed.

Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas. An Ordinance to be entitled: An Ordinance to create a new position in the County Judge's Office and to declare an emergency.

WHEREAS, Faulkner County was selected to receive American Rescue Plan ("ARP") funds from the United States federal government in the amount of \$24,475,383; and

WHEREAS, the United States federal government has placed several restrictions on the use of those funds as well as numerous reporting requirements concerning the expenditures of the money; and

WHEREAS, Faulkner County wishes to use a portion of the ARP funds to create a position of ARP Administrator to ensure the ARP funds use and reporting requirements of the Federal government are met; and

WHEREAS, Faulkner County self-insures its Health Insurance program for Faulkner County employees; and

WHEREAS, Faulkner County wishes to create a position of Insurance Administrator to ensure Faulkner County's health insurance plan is properly executed; and

WHEREAS, Faulkner County executes an annual approximate budget of \$16,000,000 with multiple contracts and purchases to maintain the county road system; and

WHEREAS, Faulkner County wishes to create a position of Roads Contract and Procurement Specialist to ensure Faulkner County's road system is properly maintained; and

WHEREAS, the above three jobs will be combined into a total of one personnel position to be funded  $\frac{1}{2}$  by Fund 3046, ARP funds,  $\frac{1}{4}$  by Fund 1000, and  $\frac{1}{4}$  by Fund 2000; and

NOW, THEREFORE, BE IT ORDAINED by the Quorum Court of Faulkner County, Arkansas:

Section 1: County Road Position 1248 (2000.0200.1248) is eliminated.

Section 2: Positions of ARP Administrator, Insurance Administrator, and Roads Contract and Procurement Specialist will be combined into a total of one personnel position, salary to be funded ½ by Fund 3046 (\$37,942.50), ARP funds, ¼ by Fund 1000 (\$18,971.25), and ¼ by Fund 2000 (\$18,971.25).

Section 3: The County Judge will have authority to manage the newly created position.


Section 4: This position line item will be designated by number 1005 in each fund and department in the annual county budget.

Section 5: The funding for this position will terminate on December 31, 2026.

Section 6: The adoption of this Ordinance is an emergency and therefore, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect on January 18, 2023.

**An Appropriation for law enforcement officer salary stipends for full-time law enforcement officers in accordance with Act 224 of the 2022 Fiscal Session of the Arkansas legislature, and to amend the annual operating budget for Faulkner County, Arkansas for calendar year 2023.**





**AN EMERGENCY ORDINANCE ADOPTING CERTAIN RULES AND REGULATIONS  
CONCERNING EXTERNAL NOISE ATTENUATION OF DATA CENTERS AND TO  
PREVENT NOISE DISTURBANCE WITHIN FAULKNER COUNTY'S  
UNINCORPORATED LIMITS; TO DECLARE AN EMERGENCY; AND FOR OTHER  
PURPOSES**

**WHEREAS**, the equipment associated with the cooling systems and generators required to operate Data Centers generate broadband noise and low-frequency hums that result in noise disturbance. Noise disturbance is the cause of degradation and may produce negative impacts on public health, property and the environment; and

**WHEREAS**, noise attenuation should be an integral part of the design and construction of Data Centers in order to prevent noise pollution and noise disturbance; and

**WHEREAS**, the county finds that the public interest is served by the prevention of unreasonable noise emanating externally from the Data Centers and the provisions of this Ordinance are enacted for the purpose of preserving and protecting the public health, safety, welfare and property of the citizens of Faulkner County, Arkansas.

**THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER  
COUNTY, ARKANSAS, AS FOLLOWS:**

**ARTICLE 1. Purpose and Applicability**

This ordinance shall only apply to noise disturbances originating within the unincorporated areas of Faulkner County, Arkansas.

**ARTICLE 2: Definitions**

For the purpose of this Ordinance, the following definitions shall apply unless the context clearly indicates or requires a different meaning:

1. *Ambient Noise*: The all-encompassing noise level associated with a given environment, being a composite of sounds from all sources, excusing the alleged offensive noise, at the

locations and approximate time at which comparison with the alleged offensive noise is to be made.

2. *Data Center*: Industrial or commercial building or facility that houses IT infrastructure for building, running, and delivering applications and services, and for storing and managing the data associated with those applications and services includes but is not limited to commercial crypto mining facilities.
3. *Decibel (dB)*: A unit for measuring the volume of a sound, equal to twenty (20) times to the base 10 (10) of the ratio of the pressure of the sound measured to the referenced pressure, which is twenty (20) micropascals (twenty (20) micronewtons per square meter.)
4. *Mechanical Equipment*: The networked computer systems along with supporting equipment such as batteries, backup generators, and cooling systems housed on the Data Center's property.
5. *Noise Disturbance* is any sound which:
  - a. Endangers or injures the safety or health of humans or animals; or
  - b. Annoys or disturbs a reasonable person of normal sensitivities; or
  - c. Endangers or injures person or property.
6. *Person*: An individual, association, partnership, or corporation, including any officer, employee, department, or agency.
7. *Property Line*: An imaginary line along the ground surface, and its vertical extension, which separates the property owned by one person from that owned by another person, but not including intra-building property divisions.
8. *Sound*: An oscillation in pressure, particle displacement, particle velocity or other physical parameter, in a medium with internal forces that causes compression and rarefaction of that medium. The description of sound may include any characteristic of such sound, including duration, intensity and frequency.
9. *Sound Level*: The weighted sound pressure level obtained by the use of a sound level meter and frequency weighting network, such as A, B, or C as specified in American National Standards Institute specifications for sound level meters (ANSI SI. 4-1971, or the latest approved revision thereof). If the frequency weighting employed is not indicated, the A-weighting shall apply.
10. *Sound Level Meter*: An instrument which includes a microphone, an amplifier, RMS detector, integrator or time averager, output meter, and weighting networks used to measure sound pressure levels.

### **ARTICLE 3: Procedure for Measurement**

All tests shall be conducted according to the following procedures:

1. *Complaint Driven*: When the measurement is the result of a complaint, measurements will be taken at the property line of the receiving property.

2. *Normal Monitoring:* When the measurement procedure is in the normal course of monitoring sound, the measurements will be taken at the property line of the source of the sound.
3. *Calibration:* The sound level meter must be calibrated at least every two years.
4. *Meter Placement:* The sound level meter must be placed a minimum of four feet above the ground or from any reflective surface. The microphone must be pointed at the sound source.
5. *Measurements:* Measurements must include “high”, “average”, and “low” readings. If the sound level meter does not provide these multiple readings, a minimum of three separate measurements must be taken at a single location at varying time intervals. The average sound level reading shall be used to determine whether there has been a violation of this Ordinance.
6. *Monitoring Report:* The report for each measurement session must include:
  - a. The day, date and time of the measurements,
  - b. Date and time of recent calibration of the sound meter,
  - c. Temperature,
  - d. Identification of the monitoring equipment,
  - e. Location, land use, and description of the source,
  - f. Location and land use of the listener, and
  - g. Sound level measurements.
7. *Extraneous Sounds:* If there are extraneous sound sources that are unrelated to the measurements and increase the monitored sound level, the measurement shall be postponed until these noises subside.

#### **ARTICLE 4: Noise Limitations**

It shall be unlawful for any Data Center to make, or continue to cause or permit to be made or continued, noise levels constituting a noise disturbance.

For the purposes of this section, the external noise level emanating from Data Centers shall be deemed a noise disturbance per se, if the sound level is 60 dBa or higher during the hours of 8 A.M. to 8 P.M. or 55 dBa or higher during the hours of 8 P.M. to 8 A.M. measured at the property line of the receiving property.

The standard which may be considered in determining whether a violation of this Ordinance exists for a noise disturbance not meeting the threshold set forth in the immediately preceding sentence includes, but is not limited to the following:

- a. The level or volume of the noise;
- b. The time of day or night the noise occurs;
- c. The duration of the noise;
- d. Whether the noise is recurrent, intermittent or constant; and

- e. Whether proper and reasonable noise attenuation methods were followed and maintained

#### **ARTICLE 5: Violations**

1. Any or all of the following persons may be held responsible for noise violations:
  - a. The person operating the equipment or creating the noise;
  - b. The person who employs the person operating the equipment or creating the noise at the time of the violation;
  - c. The person who owns or rents the property where the violation occurs.

#### **ARTICLE 6: Penalties**

- (1) Any person(s), firm, corporation, partnership, association, owner, occupant, agent or anyone having ownership in the subject property or supervision or control over the Data Center that violates or fails to comply with any provision of this Ordinance, shall be guilty of a misdemeanor.
- (2) Upon conviction of such violation, any offending party shall be punished by fine of up to \$1,000 for any one specified offense or violation. Each day of a continuing violation constitutes a separate violation. Furthermore, if the prohibited act continues after the conviction of a violation, a court may issue a fine in an amount up to \$500 for each day that the unlawful conduct continues. Additionally, the County may petition for an injunction in a court of proper jurisdiction to abate the nuisance. The county or any citizen shall be entitled to pursue all legal and equitable remedies available under the law in order to abate the nuisance and compel compliance with this Ordinance, including injunctive relief and any civil damages the court deems appropriate.

#### **ARTICLE 7: Severability**

If any provision of this Ordinance is found to be invalid by the decision of any court of competent jurisdiction, such invalidity shall not affect the remaining sections, phrases, and provisions of this Ordinance which shall remain valid and enforceable.

#### **ARTICLE 8: Emergency Clause**

The Quorum Court finds that the immediate implementation of this ordinance is necessary for the preservation of the public's peace, health, safety, welfare, and property, an emergency is hereby declared to exist and that this Ordinance is to be in effect immediately after its adoption.

**ELECTION FOR PINE VILLAGE VOLUNTEER FIRE DEPARTMENT DUES**  
**ON EACH RESIDENCE AND BUSINESS**  
**Sponsored by Justice Samuel Strain**

AN ORDINANCE PROVIDING FOR THE ELECTION, AT THE NEXT GENERAL ELECTION, FOR THOSE VOTING WITHIN THE GEOGRAPHICAL BOUNDARIES (MORE SPECIFICALLY DESCRIBED AS AREA ESN 318 ATTACHED AS EXHIBIT "A") WITHIN FAULKNER COUNTY, ARKANSAS; AND PRESCRIBING OTHER MATTERS PERTAINING THERETO.

WHEREAS, The Quorum Court of Faulkner County, Arkansas (the "County"), has received a request from Pine Village Volunteer Fire Department for the levy of volunteer fire department dues; and

WHEREAS, pursuant to Act 1480 of 2009 the Quorum Court by ordinance shall call for an election on the issue of the levy of the volunteer fire department dues on each residence and on each business having an occupiable structure, and on each parcel of unimproved land.

NOW, THEREFORE, BE IT ENACTED by the Quorum Court of Faulkner County, Arkansas;

Section 1. The Faulkner County Quorum Court, pursuant to Act 1480 of 2009, calls for an election, at the next general election, for those voting within the geographical boundaries (more specifically described as area ESN 318 attached as Exhibit "A") for which Pine Village VFD is responsible on the issue of the levying of Volunteer Fire Department dues on each residence and each business having an occupiable structure, and on each parcel of unimproved land.


Section 2. Any cost incurred shall be borne by the Pine Village VFD.


- Section 3. The dues levied by the Pine Village VFD shall be collected annually in the respective amounts as approved by the citizens of the Pine Village VFD not to exceed the following amounts:
- a. Sixty dollars (\$60) per residence or non-commercial building (including mobile housing, RV Campers, etc. used as detached living space) on a parcel of up to twenty (20) acres.
  - b. Fifteen dollars (\$15) per parcel of unimproved land up to twenty (20) acres
  - c. Ten cents (\$0.10) per acre for every acre in excess of twenty (20) acres in addition to the dues assessed under (a) or (b).
  - d. Forty-five dollars (\$45) per apartment or duplex unit per parcel.
  - e. One hundred twenty-five dollars (\$125) per parcel for each commercial or industrial business with a structure of five thousand (5000 sq. ft.) square feet or less.
  - f. One hundred fifty dollars (\$150) per parcel for each commercial or industrial business with a structure of five thousand and one (5001 sq. ft.) square feet or more.

Section 4. The dues levied by the Pine Village VFD and listed on the annual real property tax statements, if approved by the voters, shall be collected by the Faulkner County Collector and remitted to the Pine Village VFD or appropriate entity by the Faulkner County Treasurer.

Section 5. That all ordinances and parts thereof in conflict herewith are hereby repealed to the extent of such conflict.

Access to Faulkner County technical resources, including, but not limited to, computers, software, network applications, Internet, e-mail and other technology based services has been provided to officials and staff for the benefit of Faulkner County. Every official and staff member has the responsibility to use this technology in a professional manner and consistent with their elected and appointed responsibilities. The purpose of such advanced communications technology is to assist public officials and staff members in presenting a more efficient and advanced level of government services to the county. Other departments or County governmental entities availing themselves of the County network and associated software and hardware shall be compatible with the minimum standards as set by the Data Processing Department and such information regarding the minimum standards shall be distributed by Data Processing to each governmental department.~~

A. 1. This policy is established in accordance with Ark. Code Ann. § 25-1-128.

2. “Technology resources” shall be defined as:

a. The machines, devices, and transmission facilities used in information processing, including computers, word processors, terminals, telephones, cables, software, and related products;

- b. The devices used to process information through electronic capture, collection, storage, manipulation, transmission, retrieval, and presentation of information in the form of data, text, voice, or image and includes telecommunications and office automation functions;
- c. Any component related to information processing and wired and wireless telecommunications, including data processing and telecommunications hardware, software, services, planning, personnel, facilities, and training;
- d. The procedures, equipment, and software that are designed, built, operated, and maintained to collect, record, process, store, retrieve, display, and transmit information, and the associated personnel, including consultants and contractors; and
- e. All electronic mail accounts issued by a public entity.

3. The County's *technology resources* shall not be used to:

- a. Express a personal political opinion to an elected official unless the opinion is:
  - i. Within the scope of the employee's regular job duties; or
  - ii. Requested by an elected official or public entity;
- b. Engage in lobbying an elected official on a personal opinion if the employee is not a registered lobbyist for the public entity;
- c. Engage in illegal activities or activities otherwise prohibited by federal law or state law; or
- d. Intentionally override or avoid the security and system integrity procedures of the public entity.

4. Each Elected Official shall create disciplinary procedures for a violation of this policy concerning authorized use of technology resources. The disciplinary procedures created pursuant to this section shall not apply to employee communications made in compliance with the Public Employees Political Freedom Act of 1999, Ark. Code Ann. §§ 21-1-501, et seq., or the Arkansas Whistle-Blower Act, Ark. Code Ann. §§ 21-1-601, et seq.

- B. Faulkner County computing systems and associated electronic devices are provided as tools for furthering the government's business and all information created, accessed, or stored using these systems are the property of the county and/or individual governmental department and subject to monitoring, auditing, or review. Due to the fact that this equipment is property of the county it is subject to public disclosure under the Freedom of Information Act.

- C. Examples of reasons for which the specific County Department may access employee voice mail, e-mail, computer files, computer networks or other County property include, but are not limited to:
1. Instances when an employee is unavailable, but the County must access a system to operate its business.
  2. Instances when the specific Official suspects that its property is being used in an unauthorized or illegal manner.
  3. For quality control purposes or for training activities.
  4. To monitor job performance.
  5. For any other legitimate governmental purpose.
- ~~D. The following is a list of restricted activities associated with the use of the provided technology. This list is not exhaustive, and shall include but not be limited to:~~
- ~~1. Harassing, insulting or attacking others.~~
  - ~~2. Damaging computers, computer systems or computer networks.~~
  - ~~3. Violating copyright laws.~~
  - ~~4. Accessing resources not related to the user's department or work without permission.~~
  - ~~5. Intentionally wasting limited resources.~~
  - ~~6. Using or damaging the network for any purposes which violate federal, state or local laws.~~
- ~~E.D.~~ Notwithstanding any stand-alone systems, The Faulkner County Personnel Manual shall equally apply to all departments.
- ~~F.~~ ~~Violations of any guidelines listed above will be presented to the department supervisor, human resources and/or County Administrator. It may result in disciplinary action up to and including termination. If necessary, the person duly advised will contact the appropriate legal officials of any illegal violations.~~

**Sponsored by: Personnel Committee**

**Be it enacted by the Quorum Court of Faulkner County, State of Arkansas, An Ordinance to be entitled: An Ordinance to repeal and replace Faulkner County Ordinance 12-05 and 07-16 to establish reimbursements for travel expense and/or meetings or trainings sponsored by Faulkner County entities and for other lawful purposes.**

Section 1: Employee's or elected officials of Faulkner County will be reimbursed up to, but not to exceed, \$45.00 (forty-five dollars) per day for in -state travel, \$75.00 (seventy-five dollars) a day for out-of-state travel, for meals while traveling on work related business. To be eligible for reimbursement, the employee or elected official must be staying overnight, out of town and submit itemized receipts. No alcohol purchases will be reimbursed. Any purchases over the above-mentioned amounts, or for alcohol or not on an itemized receipt will be the responsibility of the traveler and not eligible for reimbursement. **A gratuity for service may be reimbursed in an amount no greater than fifteen percent (15%) of the meal price if the gratuity is clearly identified and listed on the receipt or invoice. Any gratuity in excess of fifteen percent (15%) will be the responsibility of the traveler and not eligible for reimbursement.**

Section 2: The issuance of credit cards will be at the discretion of the elected official. Credit cards shall only be used for work related purchases and an itemized receipt, from the place of purchase, must accompany the credit card bill submitted for payment. Any credit card charge purchase not accompanied by an itemized receipt, will be the responsibility of the purchaser. It shall be considered a violation of this Ordinance to knowingly purchase items for personal use, on a County issued credit card, with the intent of reimbursing the County.

Section 3: Cell phone and pager issuance to county employees, whose job description requires they be away from the office regularly and must maintain contact to effectively or safely perform their duties, will be left to the discretion of the elected official. Cell phones issued and paid by the county are for business use only. Each elected official is responsible for monitoring the phone's usage pursuant to the personnel manual. If not provided by the department or office and the employee submits a reimbursement request for the telephone usage, an itemized cellular bill must accompany the purchase order for payment.

Section 8: County funds can only be used to purchase the meals, or provide refreshment or meals at meetings/trainings held by Faulkner County elected officials, when a written agenda is submitted with the reimbursement request. Any purchases made that fall outside these parameters are the responsibility of the purchaser.





Be it enacted by the Quorum Court of Faulkner County, State of Arkansas. An Ordinance to be entitled: An appropriation Ordinance to establish the annual operating budget for calendar year 2024, to amend Faulkner County Ordinance 20-02, and to declare an emergency.

**Section 1: ANNUAL BUDGET ADOPTED BY REFERENCE.**

The annual budget for calendar year 2024 identified as “2024 Annual Budget, Faulkner County, Arkansas”, dated November, 2023 is hereby adopted by reference. A copy of said budget shall be filed in the Office of the County Clerk and shall be available for inspection and copying by any person during normal business hours.

**Section 2: NONRESTRICTED EXPENDITURE CATEGORIES.**

Expenditures of funds appropriated by this Ordinance shall not be restricted to the line-item expenditure codes comprising the four major categories of expenditures - Personal Services, Supplies, Other Services and Charges and Capital Outlays, but shall be restricted to office/departmental expenditures.

**Section 3: EXPENDITURE RESTRICTED TO SPECIFIED FUNDS.**

No expenditure of appropriated funds shall be made from any fund other than the fund specified in the Ordinance or an amendment thereto.

**Section 4: TRANSFERS.**

Any transfer of monies between the various funds of the County or between the four major categories of expenditures – Personal Services, Supplies, Other Services and Charges, Capital Outlays – shall be made only in accordance with state law or with prior approval of the Faulkner County Quorum Court. Provided, however, all transfers budgeted for in the annual budget shall be exempt from the provisions of this section.

**Section 5: Per Diem**

Article 1 of Faulkner County Ordinance 20-02 is hereby amended as follows:

Article 1. Quorum Court members may receive a per diem of \$750.00 for attending any regular meetings of the Faulkner County Quorum Court.

In accordance with A.C.A. §14-14-1205, a member of the Quorum Court may receive per diem compensation for one meeting per year for which the member is absent due to an emergency or for personal reasons. The per diem compensation shall not exceed \$14,458.00 during the calendar year of 2024.

**Section 6: REPEALER.**

All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed. If any provision of this ordinance or the application thereof to any person or circumstance is held to be invalid, such invalidity shall not affect other provisions or application of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared severable.

**Section 7: EMERGENCY CLAUSE.**


