

**PROPOSED RESOLUTION 23 - 07**

**A RESOLUTION CALLING FOR AN ELECTION AND PLACING A BALLOT REFERENDUM TO THE PEOPLE DURING THE GENERAL ELECTION IN FAULKNER COUNTY, ARKANSAS, ON THE QUESTION OF INCREASING FIRE DUES FOR THE PINE VILLAGE VOLUNTEER FIRE DEPARTMENT; AND PRESCRIBING OTHER MATTERS PERTAINING THERETO.**

WHEREAS: The Quorum Court, after a request was filed by the Pine Village Volunteer Fire Department, decided on November 21, 2023, that it is appropriate to call for an election on the issue of the levy of the volunteer fire department dues; and

WHEREAS: The Quorum Court is charged with the responsibility to request an election on the issue of the levy of volunteer fire department dues; and

**NOW, THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS, THAT:**

Article 1: That there be, and is hereby called, an election to be held on March 5, 2023, at which election there shall be submitted to the electors of the Pine Village Volunteer Fire Department Area ESN 318 the question of the levy of Volunteer Fire Department Dues.

Article 2: That the question of an increase of the levy of Volunteer Fire Department Dues for the Pine Village Volunteer Fire Department area ESN 318 shall be placed on the ballot for the election in substantially the following form:

Vote on the measure by placing an "X" in the square opposite the measure either for or against:

**ELECTION OF THE PINE VILLAGE VOLUNTEER FIRE DEPARTMENT**

An election to consider the dues levied by the Pine Village Volunteer Fire Department to be collected annually in the respective amounts of up to the following amounts:

- a. Sixty dollars (\$60) per residence or non-commercial building (including mobile housing, RV Campers, etc. used as detached living space) on a parcel of up to twenty (20) acres.
- b. Fifteen dollars (\$15) per parcel of unimproved land up to twenty (20) acres
- c. Ten cents (\$0.10) per acre for every acre in excess of twenty (20) acres in addition to the dues assessed under (a) or (b).
- d. Forty-five dollars (\$45) per apartment or duplex unit per parcel.

- e. One hundred twenty-five dollars (\$125) per parcel for each commercial or industrial business with a structure of five thousand (5000 sq. ft.) square feet or less.
- f. One hundred fifty dollars (\$150) per parcel for each commercial or industrial business with a structure of five thousand and one (5001 sq. ft.) square feet or more.

Article 3: That the election shall be held and conducted, and the vote canvassed and the results declared under the law and in the manner now provided for county elections unless otherwise provided in Title 26, Chapter 74, Subchapter 2 of the Arkansas Code of 1987 Annotated (the “Authorizing Legislation”) and only qualified voters of the County shall have the right to vote at the election.

Article 4: A copy of this Resolution shall be provided to the Faulkner County Board of Election Commissioners so that the necessary election officials and supplies may be procured. The Commissioners and County Judge are authorized and requested to take prompt actions in compliance with A.C.A. §26-74-209 in the event the measure is approved by the electors.

Article 5: That the results of the elections shall be proclaimed by the County Court, and this Proclamation shall be published one time in a newspaper having general circulation in the County.

Article 6: That the County Judge and Quorum Court, for and on behalf of the County, be, and they are hereby authorized and directed to do any and all things necessary to call and hold the election as herein provided and, if the levy of the Volunteer Fire Department dues is approved by the electors, to cause the Volunteer Fire Department Dues to be collected in accordance with the Authorizing Legislation, and to perform all acts of whatever nature necessary in a timely fashion to carry out the authority conferred by this Ordinance.

Article 7: That all ordinances and/or resolutions and parts thereof in conflict herewith are hereby repealed to the extent of such conflict.

NOW, THEREFORE BE IT RESOLVED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS, THAT THIS BODY CALLS AN ELECTION FOR THE ELECTORS OF THE AREA ESN 318 TO APPROVE THE RECENTLY PASSED LEVY OF VOLUNTEER FIRE DEPARTMENT DUES.
