

The Faulkner County Assessor's Office has been asked to do an evaluation on the following vehicles for the Faulkner County Road Department.

2001 Mack Dump Truck	1M2P267C01M057610	V.1.10	\$21,000

There was limited information to use for the estimated value. The estimated value was based on the condition of the vehicles along with using our personal property table. Per research and due to the limited information, there is not a fair market range for the vehicles listed above. I would estimate that the fair market range on the 2004 Mack Dump truck would be between \$30,000 and \$35,000 and the 2001 Mack Dump truck would be between \$19,000 and \$24,000.
