

Authorizing the borrowing of \$400,000.00 and execution of a promissory note to First Security Bank; and prescribing other matters pertaining thereto.


- Section 1: Authorization to borrow the sum of \$400,000.00 is hereby approved for the purchase of vehicles from Landers Dodge and Cavanaugh Fleet.
- Section 2: Under the authority of amendment no 78 to the Arkansas constitution and Act No. 1808 of 2001, Faulkner County shall borrow from First Security Bank the sum of \$400,000.00 for the purchase price of the equipment at a rate of 3.78% annum amortized over (3) years with yearly installments due on the first day of march 2008 and 2009.
- Section 3: As provided in amendment No.78, the annual debt service payments on the promissory note in each fiscal year shall be charged against and paid from the Criminal Justice Sales Tax Fund for such fiscal year. For the purpose of making annual debt service payments, there is hereby and appropriated to pay the promissory note, an amount of Criminal Justice Sales Tax sufficient for such purposes. The County covenants with First Security Bank that it shall not take any action or suffer or permit any action to be taken or condition to exist which causes or may cause the interest payable on the promissory note to be included in gross income for Federal Income Tax purposes
- Section 4: The County Judge on behalf of the County is hereby authorized and directed to do any and all things necessary to effect the execution and delivery of the security agent and the performance of all obligations of the County there under the issuances, execution, and delivery of the promissory note, and the performance of all acts of whatever nature necessary to effect and carry out the authority conferred by this ordinance. The County Judge is hereby further authorized and directed , for and on behalf of the County to execute all papers, documents, agreements, certificates, and other instruments that may be required for the carrying out of such authority or to evidence the exercise thereof.
- Section 5: If any provision of this Ordinance or the application thereof to any person or circumstance is held to be invalid, such invalidity shall not affect other

provisions or applications and, to this end, the provisions of this ordinance are declared to be severable.



**Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas.
An Ordinance to be entitled: an Ordinance to establish the bonding for driving
Heavy oil and gas Equipment on County Roads**

Section 1: It shall be required by Faulkner County that all Oil and Gas companies who will be driving heavy equipment on the Roads of Faulkner County shall notify the County Judge of their intent to use such roads.

Section 2: If, prior to exploration and drilling for oil and gas, it appears that an oil and gas company or an individual who is to explore and drill will be driving heavy equipment on county roads then the company or individual shall file a reasonable bond with the county, as the case may be, to cover anticipated damages to the county roads.

Section 3: The bond shall be in an amount determined by the county road foreman and supervisor to be sufficient to repair damage caused to the roads by operating the equipment on them.

Section 4: This is to be in accordance with Arkansas code 27-66-507

An Ordinance establishing road construction requirements for dedication and requirements for dedication and requiring the construction of improvements; establishing a permit fee and for other purposes

WHEREAS, Ark. Code Ann. 27-66-207 provides that the county judge, in his discretion, may designate as a county road any street or road dedicated to the public as a public thoroughfare, provided that a bill of assurance making the dedication is properly recorded.


- Article 1. Increasing development has occurred throughout several locations in the unincorporated parts of Faulkner County.
- Article 2. Residential and commercial development has led to the construction of various street improvements, which are later dedicated to the public.
- Article 3. Land development in the county frequently requires right-of-way dedications and the construction of public roads.
- Article 4. Road construction or reconstruction includes street widening, street alignment, and realignment drainage structures and piping, excavation cuts or fill sections, extensive drain structures and similar development that result in permanent construction.
- Article 5. Purchasers of property in subdivisions within unincorporated areas of Faulkner County have a reasonable expectation that the roads within the subdivision meet the specifications for inclusion into the county road system and that such roads have been approved by the County Judge of Faulkner County for subsequent maintenance as county roads;

**NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF
FAULKNER COUNTY, ARKANSAS:**

- Section 1: No person or entity shall construct, reconstruct, alter, remove, or replace any portion of a road, curb, gutter, drainage structure, or driveway abutting a dedicated street within the County with out first having obtained a permit from the Faulkner County Judge.
- Section 2: All construction, reconstruction, alterations, removal or replacement required by this ordinance shall conform to the approved standards of the Faulkner County road ordinances.
- Section 3: Any person or entity subdividing land are required to file a subdivision plat with the County Judge, and shall indicate the right-of-way to be dedicated to the public as well as the location of water lines, and fire hydrants. The plat for the said subdivision shall be approved by the County Judge before the constructions of roads are implemented.
- Section 4: The County Judge shall issue a permit upon proper submission for the construction or reconstruction of roads pursuant to this ordinance and upon payment of a one hundred dollar (\$100.00) permit fee (payable to Faulkner County Road Department) which shall be used toward the cost of administering this Ordinance
- Section 5: An emergency is hereby declared to exist as this Ordinance is necessary for the proper and timely conduct of county operations and this Ordinance shall be in force and take effect upon passage and publication.







AN ORDINANCE DESIGNATING THE "PREPARER OF THE TAX BOOKS" AND REQUIRING THE COOPERATION OF CERTAIN COUNTY OFFICIALS IN THE COMPILATION OF THE TAX COLLECTION DATA REPORT.

Section 1. Affirmation of the Court: WHEREAS, Arkansas Code § 26-26-2001, et seq. and special language in Section 10 of Act 1218 of 2007 require the county official that is the preparer of the tax books to annually report, by February 15th of each calendar year, information as required by the Rules of the Assessment Coordination Department (hereinafter "Rules").

Section 2. WHEREAS, the special language in Section 10 of Act 1218 of 2007 further mandates that failure, by the preparer of the tax books, to report the information necessary to comply with the Rules of the Assessment Coordination Department, by February 15th of each calendar year, shall result in forfeiture of reappraisal funding.


Section 3. WHEREAS, Arkansas Code § 6-20-2202(g) further mandates that the preparer of the tax books shall provide, by March 15th of calendar year, information concerning the annual abstract of assessment that reflects the aggregate value of the real and personal property for each school district, located wholly or in part, in the county; and the Treasurer of the State of Arkansas is mandated to withhold the monthly distribution of county aid from any county that fails to comply with Arkansas Code § 6-20-2202(g).

NOW THEREFORE, IT IS HEREBY ENACTED:

Section 4. To assure compliance with the above-referenced laws and rules of the Assessment Coordination Department, it is necessary for the county to designate unto an elected county office the vital function of the preparer of the tax books for the county. The Quorum Court hereby designates The Faulkner County Tax Collector as the preparer of the tax books, to annually report the information required by the above-referenced laws and rules.

Ordinance No. 07-26

BE IT ENACTED BY THE QUORUM COURT FAULKNER COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN ORDINANCE TO ESTABLISH THE RATE OF PAY AND REIMBURSEMENT FOR JURY SERVICE; TO ASSIGN RESPONSIBILITY FOR APPLYING FOR REIMBURSEMENT FROM THE STATE; AND FOR OTHER PURPOSES.

Section 1. Legislative Intent.

Pursuant to the requirements of Act 1033 of 2007, codified as Arkansas Code Annotated (ACA) 16-34-101 et seq, and in order to qualify for reimbursement from the State of Arkansas for a portion of said jury costs the Faulkner County Quorum Court hereby establishes the following minimum requirements necessary for compensation as jurors and corresponding rates of compensation for service as jurors or prospective jurors in Faulkner County, Arkansas.

- (1) The person must have received official notice that he or she has been selected as a prospective juror and summoned to appear;
- (2) The person must actually appear at the location which they were summoned; and
- (3) Their attendance must be noted in writing by the circuit clerk.

Section 2. Rates of Compensation.

The following rates of compensation are established for jury service in Faulkner County, Arkansas:

- (1) Persons who are selected and seated as a member of the jury including alternates shall be compensated at the rate of \$50.00 per day;
- (2) Persons who are summoned and appear but who are not selected and seated as a member of the jury shall be compensated at the rate of \$15.00 per day***; and
- (3) Persons summoned for jury service but who fail, for any reason, to attend court shall not be entitled to receive compensation.

Section 3. State Reimbursement Procedure and Responsibility Assignment.

Pursuant to ACA 16-34-106 the Circuit Clerk of Faulkner County, Arkansas shall be responsible for remitting, in a timely manner, all documentation required by the Administrative Office of the Courts in order to receive reimbursement for the jury cost incurred under ACA 16-34-103(b) and Section 2(1) of this ordinance.

Section 4. Repealer.

All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed. If any provision of this ordinance or the application thereof to any person or circumstance is held to be invalid, such invalidity shall not affect other provisions or application of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared severable.

Section 5. Effective Date.

This ordinance is adopted to comply with the provisions of ACA 16-34-101 et seq and shall be effective as of January 1, 2008.

Section 1: ANNUAL BUDGET ADOPTED BY REFERENCE.

The annual budget for calendar year 2008 identified as "2008 annual Budget, Faulkner County, Arkansas", dated December 27, 2007 is hereby adopted by reference. A copy of said budget shall be filed in the Office of the County Clerk and shall be available for inspection and copying by any person during normal business hours.

Section 2: NONRESTRICTED EXPENDITURE CATEGORIES.

Expenditures of funds appropriated by this Ordinance shall not be restricted to the line item expenditure codes comprising the four major categories of expenditures - Personal Services, Supplies, Other Services and Charges and Capital Outlays, but shall be restricted to office/departmental expenditures.

Section 3: EXPENDITURE RESTRICTED TO SPECIFIED FUNDS.

No expenditure of appropriated funds shall be made from any fund other than the fund specified in the Ordinance or an amendment thereto.

Section 4: TRANSFERS.

Any transfer of monies between the various funds of the County or between the four major categories of expenditures - Personal Services, Supplies, Other Services and Charges, Capital Outlays - shall be made only with prior approval of the Faulkner County Quorum Court. Provided, however, all transfers budgeted for in the annual budget shall be exempt from the provisions of this section.

Section 5: Repealer.

All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed. If any provision of this ordinance or the application thereof to any person or circumstance is held to be invalid, such invalidity shall not affect other provisions or application of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared severable.

This ordinance is adopted to comply with the provisions of ACA 16-34-101 et seq and shall be effective as of January 1, 2008.




