

The County covenants with a qualified lending institution that it shall not take any action or suffer or permit any action to be taken or condition to exist which causes or may cause the interest payable on the promissory note to be included in gross income for Federal Income Tax purposes
- Section 4: The County Judge, on behalf of the County, is hereby authorized and directed to do any and all things necessary to effectuate the execution and delivery of the security agent and the performance of all obligations of the County there under the issuance, execution, and delivery of the promissory note, and the performance of all acts of whatever nature necessary to effectuate and carry out the authority conferred by this ordinance. BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF LINDA REYNOLDS FAULKNER, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED; COUNTY CLERK

AN ORDINANCE ESTABLISHING CERTAIN RULES AND REGULATION RELATED TO THE FAULKNER COUNTY ROAD SYSTEM, ESTABLISHING AND MAINTAINING A PERMIT AND BOND PROCEDURE FOR HEAVY HAUL OPERATIONS UTILIZING COUNTY ROADS, ESTABLISHING AND MAINTAINING THE COUNTY ROAD POLICE AGENCY, SETTING FORTH THE PROVISIONS, PROCEDURES, AND PENALTIES THEREIN, AND FOR OTHER PURPOSES.

WHEREAS, the county has a duty to preserve peace and order and secure freedom from dangerous or noxious activities and, to that end, create and maintain a county road system to provide safe and consistent passage throughout the county, and the increased unregulated traffic on the Faulkner County Road System causes property damage and unsafe and dangerous conditions, which could result in circumstances that threaten the health, safety and security of the Faulkner County citizens; and

WHEREAS, the county has a significant investment in the county road system and it is incumbent upon the county to protect that investment against waste, deterioration, and destruction; and

WHEREAS, Increasing industrial and commercial development and associated transportation has occurred throughout several locations in the unincorporated parts of Faulkner County, and the county desires to mitigate the damage and destruction to its system of county roads caused by these commercial vehicles which, if left unchecked, may exceed the weight limit on the Faulkner County Road system, causing damage to Bridges, overpasses, and road surfaces. By providing for a permit and bonding mechanism for entities operating heavy hauling equipment over the county road system, the county furthers its objective of not unduly burdening its tax payers and committing waste with regard to the tax payers' investments in the county road system; and

WHEREAS, the county deems it necessary to afford the County Judge the means to enforce the rules and regulations promulgated by this body and any other laws, local, state or federal through the employment of a certified law enforcement officer under the supervision of the Faulkner County Judge or his designee.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS:

Section 1: <u>Authority</u> – Pursuant to Arkansas Code Annotated sections 27-35-101 et seq; Arkansas Act 300 of 1937; Act 742 of 1977, as amended, and the Arkansas Constitution, the county's permit, bond, and enforcement procedures for regulating heavy haul operations associated with their respective uses of the Faulkner County Road system are set forth herein.

Section 2: <u>Jurisdiction</u> – The heavy haul permit, bond, and county road police ordinance is hereby established and the following jurisdiction applies:

- a. The heavy haul permit and bonding sections of this ordinance shall apply to all county roads, highways, structures and streets within Faulkner County, Arkansas, provided these roads, highways, structures, and streets do not fall under the jurisdiction of any city within the county or are State and/or Federal Highways.
- b. The Faulkner County Road Police sections of this ordinance shall apply to all county roads, highways, structures, and streets within Faulkner County, Arkansas, provided there is no prohibition specified by law.
- Section 3: Adoption of Rules and Regulations by Reference The permit and bond administrative rules and regulations promulgated by the Faulkner County Judge's Office on behalf of Faulkner County filed with the County Clerk's Office contemporaneously with this Ordinance, adopted, and attached hereto as Exhibit "A" as if set forth herein fully word for word and is hereby established as the Faulkner County Procedures for Heavy Haul Operations Over County Roads.
- Section 4: <u>Penalties</u> Any person, business, manufacturer, refiner, retailer, wholesaler, or transporter in the private sector who pleads guilty or nolo contendere to or is found guilty of violating any provision(s) of this ordinance shall be guilty of a misdemeanor and be fined not more than two hundred-fifty dollars (\$250) per day of violation.
- Section 5: <u>Maps or Other Specific Means of Identifying Bridge Load Limits</u> the County Judge shall attach to each permit issued a map or other specific document designating and identifying the load limits for each county bridge.
- Section 6: <u>Notification of Bond Amounts for County Roads</u> attached Exhibit "A" shall set forth the mechanism with which the County Judge or his designee utilizes in setting and enforcing bond amounts for each county road.
- Section 7: <u>Civil Liability for Damaging Roads</u> Any person, business, manufacturer, refiner, retailer, wholesaler, or transporter in the private sector driving any vehicle, object, or contrivance upon any county road, highway or structure therein shall be civilly liable to the County for all damage which the highway or structure may sustain as a result of any careless, negligent, or illegal operation, driving, or moving of that vehicle, object, or contrivance, or as a result of operation, driving, or moving of any vehicle, object, or contrivance of excessive width or weighing in excess of the maximum weight as set forth in this Ordinance.

Section 8: Extreme Climatic Conditions – The County Judge may prohibit the operation of vehicles upon any highway or impose restrictions as to the weight of vehicles to be operated upon any highway, for a total period of not to exceed ninety (90) days in any one (1) calendar year, whenever the highway, by reason of deterioration, rain, snow, or other climatic conditions will be seriously damaged or destroyed unless the use of vehicles thereon is prohibited or the permissible weights thereof reduced.

Section 9: <u>Creation of Faulkner County Road Enforcement Division</u> – The Faulkner County Road Enforcement Division of the Faulkner County Road Department is hereby created and shall consist of, but not be limited to, at least one certified law enforcement officer and the necessary training and equipment to carry out the County's mandates and any and all other laws, rules, regulations, and certifications associated with employing a certified law enforcement officer.

Section 10: <u>Supervision</u> – The County Judge shall oversee the operation of the Faulkner County Road Enforcement Division of the Faulkner County Road Department and shall establish rules and regulations governing employees of the Faulkner County Road Enforcement Division consistent with the mandates of this Ordinance and all other state, federal, or local laws or ordinances to be enforced by this office.

Section 11: <u>Authority</u> – The Faulkner County Road Enforcement Division of the Faulkner County Road Shop shall have the power and authority to enforce all laws associated with the unlawful operation of motor vehicles as they relate to Faulkner County's road system, which shall include, but not be limited to, the authority to weigh vehicles and require removal of excess loads pursuant to A.C.A. § 27-35-101 *et seq.* and for all other lawful purposes not inconsistent with Arkansas law.

Section 12: <u>Severability</u> – If any provision of this ordinance is held invalid, such invalidity shall not affect the remaining provisions of the ordinance which remains effective absent the invalid provision, and to this end, the provisions of the ordinance are declared to be severable.

Section 13: <u>Emergency Clause</u> – In order to protect the Faulkner County taxpayers' investment in the county road system and to provide for necessary administrative and enforcement authority to manage the Faulkner County Road System, an emergency exists, and this ordinance, being for the immediate preservation of the public peace, health, and safety shall be in full force and effect from after its passage and approval.

# ADMINISTRATIVE RULES AND REGULATIONS CONCERNING PERMITTING AND BONDING HEAVY HAUL OPERATIONS UTILIZING COUNTY ROADS, HIGHWAYS, OR STRUCTURES

- 1. Permits and Bonding Requirements Any individual, business, manufacturer, refiner, retailer, wholesaler, or transporter in the private sector desiring to utilize any county road or structure in any manner that might result in unnecessary damages to the roadway, structure, or its drainage facilities or that might result in undue safety hazards to the public, must procure a special use permit from the Faulkner County Judge's Office. Activities subject to special use permits include, but are not limited to, any transporting of materials, equipment, or commodities, or in any equipment whose gross tonnage would be in excess of the load carrying capacity of the roads over which they travel whether associated with construction, oil and gas, chemical transportation, or any other commercial endeavor requiring the utilization of county roads or structures.
- 2. <u>Liability for Damage to County Roads or Structures</u>
  - a. Any person driving any vehicle, object, or contrivance upon any highway or highway structure shall be liable for all damage which the highway or structure may sustain as a result of any careless, negligent, or illegal operation, driving, or moving of that vehicle, object, or contrivance, or as a result of operation, driving, or moving of any vehicle, object, or contrivance of excessive width or weighing in excess of the maximum weight in this chapter.
  - b. Any person driving any vehicle, object, or contrivance upon any highway shall be liable for all damages to structures spanning the highway, or a part of the highway, by reason of load heights in excess of that which the structure will permit, when the clearance height of the structure is posted, and in any event where the height of the vehicle and load is in excess of thirteen feet, six inches (13' 6").
  - c. Whenever the driver is not the owner of the vehicle, object, or contrivance, but is operating, driving, or moving it with the express or implied permission of the owner, then the owner and driver shall be jointly and severally liable for any damage.
  - d. Damage may be recovered in a civil action brought by the authorities in control of the highway or highway structure.
- 3. Permit Application
  - a. The application for any such permit shall specifically describe the vehicle and load to be operated or moved, the origination and destination of such vehicle and load, the approximate dates in which the operation or movement is to be completed and the particular roads for which permit to operate is requested.
  - b. The County Judge's Office shall issue permits to authorized individuals or any other entities similar to the abovementioned, or shall withhold such permit at its sole discretion, but its action in withholding permit must be based on the condition and state of repair of the road involved, and ability of said road to carry

- the vehicle, or upon said danger, to the traveling public from the standpoint of safety;
- c. The County Judge's Office shall establish limitations to be imposed upon the permitted vehicles prescribing conditions of operations of such vehicles when necessary to assure against damage to the road foundation, surfaces, or structures, and to require such bond or other security as may be deemed necessary by said agency to compensate for any injury to any roadway or road structure arising out of the operation under such permit.
- d. Each such permit shall be carried in the vehicle to which it refers and shall be open to inspection by any police officer or authorized agent of any authority granting such permit and no person shall violate any of the terms or conditions of such permit.

#### 4. Basis for Establishing Bond Amount –

- a. A representative of the company seeking a permit and the Faulkner County Road Department shall inspect the roads to be utilized and survey the roads and/or road structures for current condition and status. The survey shall note any existing failures and problem areas, taking photographs of such.
- b. An estimate shall be computed concerning the cost of repairing the entire length; fixing the maximum ceiling.
- c. A bond will be set based on the cost of repair up to the maximum.
- d. A permit fee shall be collected to cover the administrative cost of the above-stated steps 1-3.
- e. The County shall hold the bond until completion of the permitted time period.
- f. Upon completion of permitted heavy haul activities the County and a representative of the company shall conduct a final on-site visit to determine damages.
- g. Payment for any damages shall be determined as follows:
  - i. The entity afforded the permit shall pay for repairs and labor.
  - ii. The payment option shall be at the discretion of the Faulkner County Judge considering the scope of existing road activity and accordingly the availability of county road equipment and labor to administer repair.
- 5. Road Survey Criteria In road survey procedures, the County shall follow guidelines in conformance with the Arkansas Highway and Transportation Department Pavement Management Program, Manual for Coding Pavement Conditions, as updated from time to time, as shall be prescribed by the Faulkner County Judge. Accordingly, the County shall utilize field inspection criteria consistent with the Arkansas Highway Department field inspection criteria.
- 6. <u>Cost Criteria to Establish Road Damage</u> The estimate of road damage cost shall be based on the Arkansas Highway Department cost criteria. This criteria primarily sets forth two sets of cost data:
  - a. Unit cost for specific work to be performed to be used in small repair work, such potholes, culverts, and shoulder repair. Cost criteria to estimate road damage shall be based upon weighted average unit price as established by the Arkansas Highway and Transportation Department, as updated from time to time.
  - b. Per mile cost used by the State Aid Engineer for reconstruction in major damage repair, as updated from time to time.

### **ORDINANCE 08-14**

Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas.

An Ordinance to be entitled:

An Ordinance establishing requirements to report hazardous materials to the Office of Emergency Services

- WHEREAS, Hazardous Materials as defined by Arkansas Code Annotated 12-79103 are: Those substances, except natural gas, manufactured, refined, or found in their natural state which, when released into the environment, by any means, have an immediate or potential threat to human, animal, or plant life and meet other criteria established under federal regulations, guidelines, or laws defining hazardous and toxic substances in a quantity and form which may pose an unreasonable risk to health and safety or property when transported in commerce, and which is designated as "hazardous material" in regulations prescribed by the United States Secretary of Transportation under Title 49 of the Code of Federal Regulations.
- WHEREAS, increasing commercial and industrial development has occurred throughout several locations in the unincorporated parts of Faulkner County
- WHEREAS, commercial and industrial development has led to the creation, storage, and handling of various hazardous materials, and
- WHEREAS, hazardous materials if spilled, or otherwise released into the environment, regardless of intent, may cause one or more emergency situations, including but not limited to, fire, explosion, ground contamination, air contamination, or water contamination, and any one or more of these hazardous materials, by their very nature, will result in public health concerns, including but not limited to, death, serious physical injuries, or property damage, and
- WHEREAS, Faulkner County as defined in Arkansas code 12-75-103 is an Emergency Management Jurisdiction, and

WHEREAS, Faulkner County Emergency Responders are charged with responding to Hazardous Material accidents or incidents, therefore, it is incumbent upon any person or entity responsible for the creation, handling, or storage of hazardous materials, or upon any person or entity with knowledge of the hazardous material'(s) presence to register that material's information with the Faulkner County Office of Emergency Management so as to insure the Faulkner County Emergency Responders know the certain chemical compositions with which they will encounter during incidents which require contact so as to contain or control these various hazardous materials.

### NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS:

- Section 1: No person or entity shall create, refine, store, hold, sell, receive, process, ship, or utilize a material, classified as a Hazardous Material, pursuant to Code of Federal Regulation, Title 49, Chapter I, Part 172 or the 2000 International Fire Code, Chapter 27, Hazardous Materials, Section 2701 et seq, as may be amended from time to time (any inconsistencies between the two preceding provisions shall be resolved in favor of the most current publication of the International Fire Codes), without first registering the following information with the Faulkner County Office of Emergency Management: (a) all persons or entities, and contact information, in actual and constructive possession of the one or more hazardous materials, (b) common and technical, if applicable, name of material, (c) hazard classification, (d) amount of material used, stored, or otherwise possessed demonstrated by the measurement commonly used in the industry, (e) area of use and storage, and (f) the entities' Emergency Action Plan, if applicable. The preceding requirements are to be provided on an ongoing basis as they become available. Should these requirements not apply to an entity at this time but are later available, the entity is at that time subject to this requirement and failure to act with due diligence in providing that information shall further subject the entity to the punishment set forth below.
- Section 2: The Director of the Faulkner County Office of Emergency
  Management or his/her designee reserves the right to enter and
  inspect for an entity's compliance with this ordinance and all related
  federal, state, and local rules and regulations related to hazardous
  materials. The Director or designee shall provide the entity 24 hours
  notice prior to the inspection. The inspection shall occur during
  regular business hours. The Director or designee shall make written

findings indicating compliance issues, a time within which those issues must be remedied, and the manner with which they must be resolved.

Any business, manufacturer, refiner, retailer, wholesaler, transporter **Section 3:** in the private sector, or governmental entity at the local, state, or federal level shall report to the Faulkner County Office of Emergency Management by the procedures promulgated by the Faulkner County Office of Emergency Management, as soon as possible, any known incident involving the release of hazardous and toxic materials into the environment which requires, or may require, emergency response or recovery actions by public safety forces of local or state governmental entities, including volunteer emergency services such as, but not limited to, firefighters, law enforcement, emergency medical services, and other first responders. This duty is cumulative and shall not relieve the business, manufacturer, refiner, retailer, wholesaler, transporter in the private sector, or governmental entity at the local, state, or federal level of liability from notifying all necessary emergency responders.

Section 3: Any person who pleads guilty or nolo contendere to or is found guilty of violating any provisions of this ordinance shall be guilty of a misdemeanor and be fined not more than two hundred-fifty dollars (\$250) per day of violation. In addition to the fine, there will be an entry of judgment for the appropriate amount of restitution associated with any known incident involving the release of hazardous and toxic materials into the environment which requires, or may require, emergency response or recovery actions.

Section 4: Any fines imposed and/or collected as a result of a violation of this Ordinance shall be applied to the Office of Emergency Management's budget.

### FAULKNER COUNTY QUORUM COURT

### **ORDINANCE 08-17**

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: "AN ORDINANCE PROVIDING FOR THE ESTABLISHMENT OF A FLOOD DAMAGE PREVENTION PROGRAM FOR FAULKNER COUNTY AND FOR OTHER PURPOSES."

WHEREAS, the Legislature of the State of Arkansas has in Ark. Code Ann. § 14-268-101 et seq., delegated the responsibility of local governmental units to adopt regulations to minimize flood losses. Therefore, the Quorum Court of Faulkner County, Arkansas, does hereby ordain as follows:

WHEREAS, the Federal Emergency Management Agency (FEMA) has identified Special Flood Hazard Areas of Faulkner County in the current scientific and engineering report entitled "The Flood Insurance Study (FIS) for Faulkner County," dated 12/19/2006, with an effective Flood Insurance Rate Map (FIRM) dated 12/19/2006.

WHEREAS, these Special Flood Hazard Areas are subject to periodic flooding events that result in loss of life and property, pose health and safety hazards, disrupt commerce and governmental services, and cause extraordinary public expenditures for flood protection and relief, all of which adversely affect the public health, safety and general welfare.

WHEREAS, these periodic flooding events are exacerbated by the cumulative effect of floodplain developments which cause an increase in flood heights and velocities, and by the placement of inadequately elevated, inadequately flood-proofed or otherwise unprotected structures or uses vulnerable to floods into Special Flood Hazard Areas. Such structures or uses are inherently hazardous to other lands because of their adverse impact on flooding events.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS:

SECTION 1. <u>LANDS TO WHICH THIS ORDINANCE APPLIES</u> - the ordinance shall apply to all Special Flood Hazard Areas within the jurisdiction of Faulkner County.

SECTION 2. <u>METHODS OF REDUCING FLOOD LOSSES</u> - this ordinance uses the following methods to accomplish the stated purpose:

A. This ordinance restricts or prohibits structures or uses in Special Flood Hazard Areas that adversely impact health, safety or property during flooding events;

- B. This ordinance requires protection against flood damage for structures or uses vulnerable to floods at the time of initial construction or after substantial improvement of the structure, or after substantial damage has occurred;
- C. This ordinance controls the alteration of natural floodplains, stream channels and natural protective barriers which are involved in the accommodation and transport of flood waters;
- D. This ordinance controls floodplain development (structural development, placement of manufactured structures, clearing, grading, mining, drilling, dredging, placement of fill, excavating, watercourse alteration, drainage improvements, roadway or bridge construction, individual water or sewer installations and other activities) which may increase flood damage by increasing flood elevations, flood water velocities, or flood discharge patterns;
- E. This ordinance regulates the construction of flood barriers which unnaturally divert floodwaters or which may adversely impact other lands.

SECTION 3. FLOOD DAMAGE PREVENTION CODE ADOPTED BY REFERENCE - there is hereby adopted by reference a "Flood Damage Prevention Code for Faulkner County, Arkansas," dated August 18, 2008. A copy of the referenced code shall be filed in the office of the Faulkner County Clerk and shall be available for inspection and copying by any person during normal office hours.

SECTION 4. <u>ABROGATION AND GREATER RESTRICTIONS</u> - this ordinance does not repeal, abrogate, or impair any existing casements, covenants, or deed restrictions. Whenever there is a conflict or overlap between this ordinance and another ordinance, easement, covenant, or deed restriction, the instrument with the more stringent restrictions applies.

**SECTION 5.** <u>INTERPRETATION</u> - in the interpretation and application of this ordinance, all provisions must:

- A. Be considered as minimum requirements;
- B. Be liberally construed in favor of the governing body; and
- C. Be deemed to neither limit nor repeal any other powers granted under State statutes.

SECTION 6. <u>WARNING AND DISCLAIMER OF LIABILITY</u> - the degree of flood protection required by this ordinance is considered reasonable for regulatory purposes. Documented scientific and engineering data form the basis for these requirements. On rare

occasions, flooding events greater than those considered for this ordinance will occur. In addition, flood heights may increase over time due to man-made or natural causes. This ordinance does not imply that land outside Special Flood Hazard Areas will be free from flooding, nor that strict adherence to this ordinance protects uses permitted within Special Flood Hazard Areas from all flood damages. This ordinance specifically does not create liability on the part of the community, nor any official or employee of the community, for any flood damages that result while strictly following this ordinance, or from any lawful administrative decision made under the provisions of this ordinance.

**SECTION 7.** COMPLIANCE - constructing, locating, substantially altering or changing the use of any structure or land after the effective date of this ordinance requires full compliance with the provisions of this ordinance and all other applicable regulations.

SECTION 8. <u>PENALTY FOR NON-COMPLIANCE</u> - flood hazards are reduced by compliance with the provisions of this code. Accordingly, enforcement of this ordinance discourages non-compliance and is a recognized mechanism for flood hazard reduction.

- A. The Floodplain Administrator must enforce the provisions of this ordinance and is authorized to:
  - a. Issue cease and desist orders on non-compliant floodplain development projects;
  - Notify local law enforcement officers and provide the requisite information and evidence so as to afford them the necessary tools to issue citations for noncompliance;
  - c. Determine the presence of a nuisance and if a nuisance is determined to be in existence, the Floodplain Administrator may petition a court of competent jurisdiction to enjoin the person or entity which owns the property or which is in actual or apparent control of the premises from maintaining the nuisance and the maintenance thereof may be abated. This action is not to be construed as a limitation placed upon any other citizen from filing an action to enjoin and abate the condition:
  - d. Request that FEMA file a 1316 Action (Denial of Flood Insurance) against non-compliant properties; and
  - e. Take any other lawful action necessary to prevent or remedy any instance of non-compliance with the provisions of this ordinance.
- B. It is a misdemeanor to violate or fail to comply with any provision of this ordinance.
- C. Any person found, in a court of competent jurisdiction, guilty of violating this ordinance is subject to fines of not more than \$500 per day for each violation; in addition the defendant is subject to payment of all associated court costs and costs involved in the case.

**SECTION 9. SEVERABILITY** - if any court of competent jurisdiction finds that any section, clause, sentence, or phrase of this ordinance is invalid or unconstitutional, that finding in no way affects the validity of the remaining portions of this ordinance.

SECTION 10. EMERGENCY CLAUSE - it is hereby found and declared by the Faulkner County Quorum Court that severe flooding has occurred in the past within its jurisdiction and will certainly occur within the future; that flooding is likely to result in infliction of serious personal injury or death, and is likely to result in substantial injury or destruction of property within its jurisdiction; in order to effectively comply with minimum standards for coverage under the National Flood Insurance Program; and in order to effectively remedy the situation described herein, it is necessary that this ordinance become effective immediately. Therefore, an emergency is hereby declared to exist, and this ordinance, being necessary for the immediate preservation of the public peace, health and safety, shall be in full force and effect from and after its passage and approval.

  - (a) Hard Surface within this Ordinance, this term shall mean asphalt, concrete or chip/seal surfacing to the specifications specifically delineated.
  - (b) Surface Specifications
    - a. Asphalt -

- i. A minimum of six (6) inches of Class 7 gravel compacted upon the road bed:
- ii. Three (3) inches of asphalt overlay for the width of the road.

#### b. Concrete –

- i. A minimum of six (6) inches of Class 7 gravel compacted upon the road bed:
- ii. Seven (7) inches of 3000 psi concrete.

### c. Chip/Seal -

- i. A minimum of six (6) inches of Class 7 gravel compacted upon the road bed:
- ii. Oil shot at .40 thickness per linear foot or greater;
- iii. Aggregate 19 pounds per cubic foot, or greater;
- iv. ½ inch of chips on the first seal; and
- v.  $\frac{1}{2}$  to 5/8 inch of chips on the second seal.
- Article 4: In addition to the requirements previously imposed by the abovementioned Ordinances, specifically set forth in Article 1, the persons or entities requesting acceptance shall, prior to acceptance, request an inspection by the duly authorized representative of the Faulkner County Judge's Office so as to ensure the presence of the appropriate hard surface and specifications related thereto.
- Article 5: An emergency is hereby declared to exist as this Ordinance is necessary for the proper and timely conduct of county operations and this Ordinance shall be in force and take effect upon passage and publication.

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS; AN ORDINANCE TO BE ENTITLED: AN ORDINANCE TO RECOGNIZE PARAMEDIC AMBULANCE SERVICES AS A PROFESSIONAL SERVICE FOR FAULKNER COUNTY, PURSUANT TO A.C.A. § 19-11-801(c); AND FOR OTHER PURPOSES.

WHEREAS, the Quorum Court finds that it is in the best interest of the citizens of Faulkner County to have a highly qualified paramedic ambulance service to respond to emergency and non-emergency requests for assistance within the county; and

WHEREAS, competitive bidding laws require that contracts, other than professional services contracts, be awarded to the lowest responsible bidder; and

WHEREAS, the Quorum Court finds that awarding a bid for paramedic ambulance services to the low bidder is contrary to its intent to have a highly qualified paramedic ambulance service, with costs of services being less significant than quality of service; and

WHEREAS, A.C.A. § 19-11-801(c) provides that counties, among other political subdivisions of the state, may elect to not use competitive bidding for professional services by passage of an ordinance by 2/3 vote to declare a service professional and electing to no use competitive bidding.

### NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS, THAT:

- Article 1: The Quorum Court of Faulkner County, Arkansas declares paramedic ambulance services to be a professional service.
- Article 2: Pursuant to A.C.A. § 19-11-801(c), competitive bidding shall not be used for the procurement of paramedic ambulance services in Faulkner County, but pursuant to the abovementioned statute, the county shall select three (3) qualified paramedic ambulance firms and shall then select the firm considered the best-qualified and capable of performing the desired work and negotiate a contract for the project with the firm selected.
- Article 3: In evaluating the qualifications, the county shall consider the following:

  A. The specialized experience and technical competence of the firm with respect to the type of professional services required; and

- B. The capacity and capability of the firm to perform the work in question, including specialized services, within the time limitations fixed for the completion of the project; and
- C. The past record of performance of the firm with respect to such factors as control of costs, quality of work, and ability to meet schedules and deadlines; and
- D. The firm's proximity to and familiarity with the area in which the project is located.
- Article 4: Severability In the event any portion of this ordinance is declared or adjudged invalid or unconstitutional, such declaration or adjudication shall not affect the remaining portions of this ordinance, which shall remain in full force and effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of this ordinance and the remaining portions of the ordinance shall be executed fully and faithfully.
- Article 5: Repealer All ordinances and resolutions, and parts thereof, which are in conflict with any provision of this ordinance are hereby repealed to the extent of such conflict.
- Article 6: An emergency is hereby declared to exist as this Ordinance is necessary for the proper and timely conduct of county operations and this Ordinance shall be in force and take effect upon passage and publication.



### **FAULKNER COUNTY QUORUM COURT**

#### **ORDINANCE 08-27**



BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS; AN ORDINANCE TO BE ENTITLED: AN ORDINANCE CREATING THE OFFICE OF COUNTY CIVIL ATTORNEY AND FOR OTHER PURPOSES.

WHEREAS, absent the creation and funding of the Office of the Faulkner County Civil Attorney, Faulkner County is left with the minimal level of services; and

WHEREAS, the creation of the Office of County Civil Attorney provides an avenue for commencement, prosecution, and defense of all civil actions in which the County is concerned, render opinions, as requested, to any township or county official on any question of civil law concerning the county which is pending before the official, and perform all civil duties the laws of the State of Arkansas mandates are to be performed by the prosecuting attorney.

### NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS, THAT:

Section 1: The office of the County Civil Attorney is hereby created pursuant to the authority granted by, and in accord with the provisions of A.C.A. § 16-21-114, which states:

- (a) A county civil attorney or county attorney may be selected pursuant to ordinance of the quorum court for each county in the state.
- (b) The county attorney shall commence and prosecute or defend all civil actions in which his county is concerned.
- (c) The county attorney shall give his opinion, without fee or reward, to any township or county official on any question of civil law concerning the county which is pending before the official.
- (d) All civil duties provided by the laws of the State of Arkansas or the ordinances of the several counties to be performed by the prosecuting attorney shall be performed by the county attorney in those counties which have established the office of civil attorney.
- (e) The office of county attorney shall be funded pursuant to ordinance of the quorum court of the county.
- (f) (1) In counties having a full-time office of county civil attorney or a contract county civil attorney, every municipality, school district, and other local taxing unit receiving ad valorem or other tax funds collected by county collectors shall reimburse the county for the taxing unit's pro rata share of the necessary legal costs incurred by the county in assessing property, collecting taxes, and receiving and disbursing revenues for the unit.
  - (2) Such legal costs shall include:

- (A) Reasonable expenses incurred by a county civil attorney and his staff while providing tax-related legal services for the unit; and
- (B) A percentage of the salaries and fringe benefits of a full-time county civil attorney and his staff based on the ratio between time spent on tax-related legal services for the taxing unit and time spent on all legal services; and
- (C) A reasonable fee charged by a contract county civil attorney for services rendered regarding the assessment, collection, receipt, or disbursement of taxes.
- (3) The amount to be reimbursed annually by each taxing unit, as its pro rata share of the county's necessary legal costs, shall be based on the proportion that the total of taxes collected for the benefit of each taxing unit bears to the total of taxes collected for the benefit of all taxing units.
- (4) To facilitate reimbursement, there is hereby created a county attorney's fund, which shall be administered in the same manner as the county assessor's fund established in § 14-15-204.
- Section 2: The County Attorney shall attend the regular monthly Quorum Court meetings and all Special Quorum Court meetings and advise County Officials and represent the County in all civil law matters.
- Section 3: The County Civil Attorney shall be compensated from the County General Fund.
- Section 4: The County Civil Attorney shall be authorized to associate co-counsel, as needed, provided that the County shall not be obligated for compensation beyond the amounts duly appropriated for the provision of County Civil Attorney services.
- Section 5: Severability – In the event any portion of this ordinance is declared or adjudged invalid or unconstitutional, such declaration or adjudication shall not affect the remaining portions of this ordinance, which shall remain in full force and effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of this ordinance and the remaining portions of the ordinance shall be executed fully and faithfully.

Section 6: An emergency is hereby declared to exist as this Ordinance is necessary for the proper and timely conduct of county operations and this Ordinance shall be in force and take effect upon passage and publication.
