



BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN ORDINANCE APPORTIONING MONEYS DERIVED FROM THE FIRE PROTECTION PREMIUM TAX FUND TO THE DISTRICTS AND MUNICIPALITIES WITHIN FAULKNER COUNTY AND OTHER PURPOSES

WHEREAS, pursuant to A.C.A. § 14-284-401 *et seq.*, the Faulkner County Intergovernmental Cooperation Council (hereinafter IGC) met November 30, 2009 to determine the districts and municipalities' needs associated with the apportionment of moneys derived from the Fire Protection Premium Tax Fund; and

WHEREAS, the IGC, based on the needs, determined the amount of money to be apportioned to each district or municipality for 2010 and unanimously voted to adopt the amount determined, more specifically delineated in Exhibit "A," which is attached hereto and incorporated by reference herein as if set forth fully word for word; and

WHEREAS, the IGC, by and through the presentation of Exhibit "A," has notified the Quorum Court of the districts and municipalities' needs and the proposed apportionments.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS THAT:

Section 1: Pursuant to A.C.A. § 14-284-401 *et seq.*, the Faulkner County Quorum Court hereby adopts the IGC's proposed apportionments and authorizes the suggested distributions; and


Section 2: Should any court of competent jurisdiction find that any section, clause, sentence, or phrase of this ordinance is invalid or unconstitutional, the finding of invalidity or unconstitutionality in no way affects the validity of the remaining portions of this ordinance and it shall be as if the invalid or unconstitutional section, clause, sentence, or phrase was omitted from the original.

Section 3: An emergency is hereby declared to exist as this Ordinance is necessary for the proper and timely conduct of county operations and this Ordinance shall be in force and take effect upon passage and publication.





ORDINANCE 10-04

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE MANDATING ETHICAL CONDUCT FOR ALL COUNTY OFFICIALS AND EMPLOYEES; AND FOR OTHER PURPOSES.

WHEREAS, the holding of public office or employment is a public trust created by the confidence which the electorate reposes in the integrity of officers and employees of county government; and

WHEREAS, an officer or employee shall carry out all duties assigned by law for the benefit of the people of the county.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS:

Section 1: Definition of Officials and Employees – (i) all elected county and township officers; (ii) all district judicial officers serving a county; (iii) all members of county boards, advisory, administrative, or subordinate service districts; and (iv) all employees thereof.

Section 2: The following shall be considered rules of conduct for all officials and county employees:

- (i) No public official or county employee shall use or attempt to use his or her official position to secure special privileges or exemptions for himself or herself or his or her spouse, child, parents, or other persons standing in the first degree of relationship, or for those with whom he or she has a substantial financial relationship that are not available to others except as may be otherwise provided by law; further, no public official or county employee shall accept employment or engage in any public or professional activity while serving as a public official which he or she might reasonably expect would require or induce him or her to disclose any information acquired by him or her by reason of his or her official position which is declared by law or regulation to be confidential.
- (ii) The officer or employee may not use his or her office, the influence created by his or her official position, or information gained by virtue of his or her position to advance his or her individual personal economic interest or that of an immediate member of his or her family or an



associate, other than advancing strictly incidental benefits as may accrue to any of them from the enactment or administration of law affecting the public generally.

- (iii) No public official or employee shall be interested, either directly or indirectly, in any contract or transaction made, authorized, or entered into on behalf of the county or an entity created by the county, or accept or receive any property, money, or other valuable thing for his or her use or benefit on account of, connected with, or growing out of any contract or transaction of a county. Further, any discounts, allowances, or credits given as a result of the type of contract contemplated above, shall be for the sole benefit of the County.
- (iv) Acquire an interest in any business or undertaking which he or she has reason to believe may be directly affected to its economic benefit by official action to be taken by county government; should the official or employee have an interest in any business or undertaking, prior to becoming an official or employee, which may have a direct affect on its economic viability by official action to be taken by county government, the official or employee shall withdraw its offer of goods or services from consideration or the Quorum Court shall, by ordinance, permit consideration of the goods or services due to specifically delineated unusual circumstances as set forth in the relevant Arkansas statutes.

Section 3: Violation of the Rules of Ethical Conduct – Any citizen of a county or the prosecuting attorney of a county may bring an action in the circuit court in which the county government is located to remove from office any officer or employee who has violated the rules of conduct set forth in this section. Pending final judgment, an officer or employee who has been charged as provided in this section may be suspended from his or her office or position of employment without pay by Order of the presiding Circuit Judge. Should the officer or employee be acquitted, that officer or employee shall be reinstated and receive all applicable back pay as if that officer or employee had never been suspended. Upon acquittal, the officer or employee shall be awarded reasonable legal fees as determined by the Circuit Court or Appellate Court(s). Any award of legal fees shall be paid out of the general fund of the County Treasurer.

Section 4: Punishment – A conviction of this Ordinance shall be deemed a misdemeanor and a fine shall be levied in an amount not less than \$300.00 nor more than \$1,000.00, and the convicted officer or employee shall be removed from office or employment.

Section 5: Repealer – All local laws or parts of laws in conflict with this Ordinance are hereby repealed to the extent of the conflict.


Section 6: Severability – If any provision of this ordinance is held invalid, such invalidity shall not affect the remaining provisions of the ordinance which remains effective absent the invalid provision, and to this end, the provisions of the ordinance are declared to be severable.

Section 7: Emergency Clause – In order to ensure the public trust is maintained in Faulkner County, an emergency hereby exists, and this ordinance, being for the immediate preservation of the public trust, shall be in full force upon passage, approval, and publication by the local officials.



**BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS; AN ORDINANCE TO APPROPRIATE FUNDS RECEIVED UNDER ACT 799 OF 2003 TO BE APPROPRIATED AND EXPENDED FOR FISH AND WILDLIFE CONSERVATION AND FOR OTHER LAWFUL PURPOSES.**

WHEREAS, pursuant to A.C.A. § 15-41-209, fine monies deposited as special revenues in the Game Protection Fund may be expended in the form of grants for fish and wildlife conservation education and other purposes consistent with Arkansas Constitution, Amendment 35; and

WHEREAS, pursuant to A.C.A. § 15-41-209, the Arkansas Department of Education has received monies associated with the Game Protection Fund and has distributed the sum of \$5,384.72 to Faulkner County for distribution pursuant to the applicable law.

**NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS, THAT:**

**Article 1:** The sum of \$5,384.72 received from the Arkansas Department of Education and forwarded to Faulkner County shall be distributed to the below-mentioned eligible recipients for the purposes specifically set forth in A.C.A. § 6-16-1101, e.g. the study of general fish and wildlife conservation issues, hunter education training, fishing education training, boating education training, wildlife habitat development, Project WILD, and the Hooked on Fishing.



Section 2: Any department's loss of funds from the Fund shall be for that fiscal period within which the department is ineligible. Should the department remedy the circumstances which rendered it ineligible or unqualified, the department or departments shall be eligible to receive funds from the Fund the following fiscal period.



AN ORDINANCE PROHIBITING THE PURCHASE, POSSESSION, SALE, AND OFFERING FOR SALE THE SYNTHETIC CANNABINOID, KNOWN AS "SPICE" OR "K-2" AND FOR OTHER PURPOSES.

WHEREAS, the county has a duty to preserve peace and order and secure freedom from dangerous or noxious activities and, to that end, the Quorum Court of Faulkner County, Arkansas has determined that certain businesses within Faulkner County, Arkansas are contemplating the sale of certain substances, which, when ingested, produce intoxicating effects similar to THC or marijuana; and

WHEREAS, the substances are not yet categorized controlled substances under state or federal law; and

WHEREAS, the substances, which are more specifically described below, are often used as an alternative to marijuana and are potentially dangerous to users and further, the long term effects are not yet known; and

WHEREAS, it has been determined that the effects of these substances are a health and safety concern to the citizens of Faulkner County, Arkansas.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS:

Section 1: It is hereby declared to be unlawful for any person to use, possess, purchase, attempt to purchase, sell, publicly display for sale or attempt to sell, give, or barter any one or more of the following chemicals within the boundaries of Faulkner County, Arkansas:

- (1) Salviadinorum or salvinatorum A; all parts of the plant presently classified botanically as salviadinorum, whether growing or not, the seeds thereof, any extract from any part of such plant, and every compound, manufacture, salts derivative, mixture or preparation of such plant, its seeds or extracts;
- (2) (6aR, 10aR)-9-(hydroxymethyl)-6, 6dimethyl-3-(2-methyloctan-2-yl)-6a,7, 10, 10a-tetrahydrobenzo[c]chromen-1-o1 some trade or other names: HU-210;
- (3) 1-Pentyl-3-(1-naphthoyl)indole-some other trade or other names: JWH-018/spice;
- (4) 1-Butyl-3-(1 naphthoyl)indole – some trade or other names: JWH-073;

(5) 1-(3-[trifluoromethylphenyl]) piperazine – some other trade or other names:  
TFMPP;

(6) Or any similar structural analogs.

Section 2: This Ordinance shall be enforced by any certified law enforcement officer within his/her respective jurisdiction within the geographical boundaries of Faulkner County. Further, this Ordinance shall apply and be enforced in all unincorporated areas and may be enforced in the incorporated areas or other municipal entities within the geographical boundaries of Faulkner County. If any of the aforementioned substances are found in the possession of any person, they may be confiscated and destroyed by law enforcement officials.

Section 3: It is not an offense under Section 1 above of this Ordinance if the person was acting at the direction of an authorized law enforcement agent to enforce or ensure compliance with this law prohibiting the sale of the aforementioned substance.

Section 4: This Ordinance does not apply to any person who commits any act described in this Ordinance pursuant to the direction or prescription of a licensed physician or dentist authorized to direct or prescribe such act. This Ordinance likewise does not apply to the inhalation of anesthesia for a medical purpose or dental purpose.

Section 5: Any person found to be in violation of this Ordinance will be guilty of a misdemeanor and subject to a term of imprisonment not to exceed one year and a fine not to exceed \$1,000.00.

Section 6: Emergency Clause – It is hereby declared that an emergency exists and this Ordinance being necessary for the preservation of the health, safety and welfare of citizens of Faulkner County, Arkansas, shall be effective immediately upon its passage and approval.

Section 7: Severability – If any provision of this ordinance is held invalid, such invalidity shall not affect the remaining provisions of the ordinance which remains effective absent the invalid provision, and to this end, the provisions of the ordinance are declared to be severable.



**Section 1: ANNUAL BUDGET ADOPTED BY REFERENCE.**

The annual budget for calendar year 2011 identified as "2011 annual Budget, Faulkner County, Arkansas", dated December 28, 2010 is hereby adopted by reference. A copy of said budget shall be filed in the Office of the County Clerk and shall be available for inspection and copying by any person during normal business hours.

**Section 2: NONRESTRICTED EXPENDITURE CATEGORIES.**

Expenditures of funds appropriated by this Ordinance shall not be restricted to the line item expenditure codes comprising the four major categories of expenditures - Personal Services, Supplies, Other Services and Charges and Capital Outlays, but shall be restricted to office/departmental expenditures.

**Section 3: EXPENDITURE RESTRICTED TO SPECIFIED FUNDS.**

No expenditure of appropriated funds shall be made from any fund other than the fund specified in the Ordinance or an amendment thereto.

**Section 4: TRANSFERS.**

Any transfer of monies between the various funds of the County or between the four major categories of expenditures - Personal Services, Supplies, Other Services and Charges, Capital Outlays - shall be made only with prior approval of the Faulkner County Quorum Court. Provided, however, all transfers budgeted for in the annual budget shall be exempt from the provisions of this section.

**Section 5: REPEALER.**

All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed. If any provision of this ordinance or the application thereof to any person or circumstance is held to be invalid, such invalidity shall not affect other provisions or application of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared severable.


**Section 6: EFFECTIVE DATE.**

This ordinance is adopted to comply with the provisions of A.C.A. § 16-34-101 et seq and shall be effective as of January 1, 2011.


