BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER,
STATE OF ARKANSAS, AN ORDINANCE TO ESTABLISH REIMBURSEMENTS FOR
TRAVEL EXPENSES AND/OR MEETINGS OR TRAININGS SPONSORED BY
FAULKNER COUNTY ENTITIES AND FOR OTHER LAWFUL PURPOSES.


- Section 1: Employee's or elected officials of Faulkner County will be reimbursed up to, but not to exceed, \$45.00 (forty-five dollars) per day for in state travel, \$75.00 (seventy-five dollars) a day for out of state travel, for meals while traveling on work related business. To be eligible for reimbursement, the employee or elected official must be staying overnight, out of town and submit itemized receipts. No alcohol purchases will be reimbursed. Any purchases over the above mentioned amounts, or for alcohol or not on an itemized receipt will be the responsibility of the traveler and not eligible for reimbursement. No tips will be reimbursed.
- Section 2: The issuance of credit cards will be at the discretion of the elected official. Credit cards shall only be used for work related purchases and an itemized receipt, from the place of purchase, must accompany the credit card bill submitted for payment. Any credit card charge purchase not accompanied by an itemized receipt, will be the responsibility of the purchaser. It shall be considered a violation of this Ordinance to knowingly purchase items for personal use, on a County issued credit card, with the intent of reimbursing the County.
- Section 3: Cell phone and pager issuance to county employees, whose job description requires they be away from the office regularly and must maintain contact to effectively or safely perform their duties, will be left to the discretion of the elected official. Cell phones issued and paid by the county are for business use only. Each elected official is responsible for monitoring the phone's usage pursuant to the personnel manual. If not provided by the department or office and the employee submits a reimbursement request for the telephone usage, an itemized cellular bill must accompany the purchase order for payment.
- Section 4: Faulkner County will not reimburse or pay college tuition for its employees or elected officials.
- Section 5: All airline travel should utilize coach accommodations. No first class travel will be authorized or reimbursed.

- Section 6: Room rates should be limited to single room or government rates, unless occupied by more than one employee. No in room movie charges, game charges or entertainment charges of any kind will be reimbursed by Faulkner County.
- Section 7: County funds can only be used to purchase the meals, or provide refreshment or meals at meetings/trainings held by Faulkner County elected officials, when a written agenda is submitted with the reimbursement request. Any purchases made that fall outside these parameters are the responsibility of the purchaser.
- Section 8: An emergency is hereby declared to exist as this Ordinance is necessary for the proper and timely conduct of county operations and this Ordinance shall be in force and take effect upon its passage and publication.

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED: AN ORDINANCE ESTABLISHING AN ORDERLY SYSTEM FOR UTILITY REQUIREMENTS AND PLAT MAPPING REQUIREMENTS INVOLVING 9-1-1 PROPERTY ADDRESSING FOR FAULKNER COUNTY.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF FAULKNER COUNTY, STATE OF ARKANSAS, an ordinance to establish an orderly system for utility requirements and plat mapping.

Article 1: Utility Requirements: No person, firm, corporation, partnership, or other entity shall authorize any public utility company as defined by Arkansas Law to supply any services to any new or existing residence or business in the unincorporated areas of Faulkner County until an address has been assigned by the Faulkner County 9-1-1 Office.

Article 2: No public utility company as defined by Arkansas Law shall supply any services to any new or existing residence or business in the unincorporated areas of Faulkner County until an address has been assigned by the Faulkner County 9-1-1 Office.

Article 3: Pursuant to Ark. Code Ann. §14-14-906, any person, firm, partnership or other entity violating this Ordinance shall be guilty of a violation punishable by a fine up to \$100.00. Each day while such violation exists shall constitute a separate punishable offense.


Article 4: Plat: The Faulkner County Circuit Clerk will not accept any plat map from a person, firm, corporation, partnership or other entity until the Faulkner County 9-1-1 Office has approved the addresses and/or street name.

Article 5: Emergency Clause. It is hereby found and determined that the unincorporated areas of Faulkner County currently have no uniform system for utility requirements or plat maps. It is hereby recognized that this system would assist emergency services in locating roads and addresses. Therefore, an emergency is declared to exist, and this Ordinance being necessary for preservation and protection of the public health, safety, and welfare of Faulkner County.





BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF FAULKNER, STATE OF ARKANSAS; AN ORDINANCE TO BE ENTITLED: AN ORDINANCE AMENDING ORDINANCE 12-19 TO CLARIFY THE 911 ADDRESS VERIFICATION REQUIREMENT AND TO REQUIRE THAT WRITTEN VERIFICATION OF A 911 ADDRESS BE OBTAINED FROM THE FAULKNER COUNTY OEM/911 OFFICE AND FOR OTHER PURPOSES.

WHEREAS, the Quorum Court passed Ordinance 12-19 establishing an orderly system for utility requirements and plat mapping, and requiring that a 911 address be obtained prior to obtaining utilities; and

WHEREAS, the Quorum Court desires to clarify the 911 address verification to require that written verification be obtained from the Faulkner County OEM/911 Office; and

WHEREAS, it is in the best interests of the Court and its citizens and residents to amend and clarify the 911 address verification requirements.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF FAULKNER COUNTY, ARKANSAS, THAT:

Article 1: Article 1 of Ordinance 12-19 is hereby amended in its entirety to read as follows: "Utility Requirements: No person, firm, corporation, partnership, or other entity shall authorize any public utility company to supply any services to any new or existing residence or business in the unincorporated areas of Faulkner County unless the resident or business owner first provides a copy of the written verification from the Faulkner County OEM/911 Office that an address has been assigned."

Article 2: Article 2 of Ordinance 12-19 is hereby amended in its entirety to read as follows: "No public utility company shall supply any services to any new or existing residence or business in the unincorporated areas of Faulkner County unless the resident or business owner first provides a copy of the written verification from the Faulkner County OEM/911 Office that an address has been assigned."

Article 3: Except as specifically amended by this Ordinance, Ordinance 12-19 is hereby ratified and confirmed.


Article 4: Severability – In the event any portion of this ordinance is declared or adjudged invalid or unconstitutional, such declaration or adjudication shall not affect the remaining portions of this ordinance, which shall remain in full force and effect as if the portion so declared or adjudged invalid or unconstitutional was not originally a part of this ordinance and the remaining portions of the ordinance shall be executed fully and faithfully.


Article 5: All ordinances in conflict herewith are repealed to the extent of the conflict.

Article 6: It is hereby recognized that this system would assist emergency services in locating roads and addresses. Therefore, an emergency is declared to exist, and this Ordinance being necessary for preservation and protection of the public health, safety, and welfare of Faulkner County, this Ordinance shall be in force and take effect upon passage and publication.

Be it enacted by the Quorum Court of Faulkner County, State of Arkansas, An Ordinance to be entitled: An appropriation Ordinance to establish the annual operating budget for calendar year 2013.

Section 1: ANNUAL BUDGET ADOPTED BY REFERENCE.

The annual budget for calendar year 2013 identified as "2013 annual Budget, Faulkner County, Arkansas", dated December 18, 2012 is hereby adopted by reference. A copy of said budget shall be filed in the Office of the County Clerk and shall be available for inspection and copying by any person during normal business hours.

Section 2: NONRESTRICTED EXPENDITURE CATEGORIES.

Expenditures of funds appropriated by this Ordinance shall not be restricted to the line item expenditure codes comprising the four major categories of expenditures - Personal Services, Supplies, Other Services and Charges and Capital Outlays, but shall be restricted to office/departmental expenditures.

Section 3: EXPENDITURE RESTRICTED TO SPECIFIED FUNDS.

No expenditure of appropriated funds shall be made from any fund other than the fund specified in the Ordinance or an amendment thereto.

Section 4: TRANSFERS.

Any transfer of monies between the various funds of the County or between the four major categories of expenditures - Personal Services, Supplies, Other Services and Charges, Capital Outlays - shall be made only with prior approval of the Faulkner County Quorum Court. Provided, however, all transfers budgeted for in the annual budget shall be exempt from the provisions of this section.

Section 5: REPEALER.

All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed. If any provision of this ordinance or the application thereof to any person or circumstance is held to be invalid, such invalidity shall not affect other provisions or application of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared severable.


Section 6: EFFECTIVE DATE.

This ordinance is adopted to comply with the provisions of A.C.A. § 16-34-101 et seq and shall be effective as of January 1, 2013.
