Because of the growth of our water system and geographical elevations we are having water hydraulic issues getting water to the south part of our system.

With the demand for more water and fire protection this project will be essential to maintaining ample water supply and fire protection throughout our water system. Our goal is simple. We want everyone that needs water to have it. Throughout the pandemic people needed water to help stay safe from the virus. Adding this Master Meter and 6,200 feet of water line will allow Guy water system to meet that goal with extra benefits. Every day each of us expect our water to be flowing, safe and having fire protection is a bonus. Having running potable water during an emergency is priceless. This is what the American Rescue Plan Act was designed for.

Guy Water is asking the Faulkner County Judge and Quorum court to fund this project in partnership with the State of Arkansas both using the American Rescue Plan Act. An application has already been sent to the State of Arkansas to fund half of this project.

1. Master Meter at South part of water system.
  - a. Water supply to the south part of our system is limited. Customers on the south end of the system experienced reduced water pressure during the resent drought. With more growth our system will find it harder to supply water to this area. Geographically we serve water customers to the north side of Greenbrier. Our water intake now is in Guy with our water storage tank being northeast of Guy. Based on the Health Department’s review of other development projects in Guy’s service area, it is extremely unlikely that the Health Department will them to be served without the completion of these improvements.

- b. We also struggled to keep enough water during the Deep Freeze in February 2021.
- c. This project has been approved by Water/Wastewater Advisory Committee.
- d. This project consists of
  - i. New master meter and connection to Community Water systems
  - ii. Laying 2,700 feet of 8-inch water line with 3,500 feet of 6-inch water line.
- e. Estimated total expense of project \$1,056,488.00

Guy Water runs on a very tight budget each year. Any additional funds would have to come out of the operating account. This could only be done as Guy Water could afford it.

The City of Guy Council approves an operating Budget each year.

- 1. Guy Water has an independent Auditor audit its financials each year.
  - a. Guy Water submits this audit the State Legislature and any lenders that require it.
- 2. Guy Water financial management will be handled in the same way we meet the guidelines of the state of Arkansas.

What is the total dollar amount that is being requested from Faulkner County?

Total Estimate-Guy Water has been awarded \$80,000 for the Water line relocation on Wolf Branch Rd. \$190,000 for the Water line Extension on Breaux Lane. We are asking for \$ 528,244.00 for a Master Meter. **This would put the total for Guy Water at \$ 798,244.00**

Have you received other ARPA funds? If so, how much have you received?

The City of Guy (as did all Arkansas Cities) received Funds from the American Rescue Plan Act State and Local Fiscal Recovery Funds ("SLFRF"). Total funds received \$163,258.51. These funds are being used for Covid Employee recovery expense, Premium pay for employee's who worked thru the Pandemic. The remainder of the funds are being spent for water infrastructure replacing old water lines.
