## **New Business:**

Justice Lachowsky made a motion to accept Proposed Resolution 24-07, and such motion was seconded by Justice Moss. Counsel Murphy read Proposed Resolution 24-07 by title only. After discussion, Judge Dodson called for a vote by roll call for Proposed Resolution 24-07. The roll was called and Proposed Resolution 24-07 passed with a vote of 13-0.

The Court discussed Proposed Ordinance 24-47. This is an appropriation Ordinance to amend and supplement Faulkner County Ordinance 23-36 (November 21, 2023), and to declare an emergency. Justice Lachowsky made a motion to accept Proposed Ordinance 24-47, and such motion was seconded by Justice Moss. Counsel Murphy read Proposed Ordinance 24-47 by

title only. After discussion, Judge Dodson called for a vote by roll call for Proposed Ordinance 24-47. The roll was called and Proposed Ordinance 24-47 passed with a vote of 13-0.

The Court discussed Proposed Ordinance 24-48. This is an Ordinance appropriating and levying millage taxes on all properties, real and personal, in Faulkner County, and for other purposes. Justice Tyler made a motion to accept Proposed Ordinance 24-48, and such motion was seconded by Justice Lyon. Counsel Murphy read Proposed Ordinance 24-48 by title only. After discussion, Judge Dodson called for a vote by roll call for Proposed Ordinance 24-48. The roll was called and Proposed Ordinance 24-48 passed with a vote of 13-0.

The Court discussed Proposed Ordinance 24-49. This is an appropriation Ordinance to amend and supplement Faulkner County Ordinance 23-36 (November 21, 2023), and to declare an emergency. Justice Tyler made a motion to accept Proposed Ordinance 24-49, and such motion was seconded by Justice Kendrick. Counsel Murphy read Proposed Ordinance 24-49 by title only. Justice Lachowsky made a motion to accept Proposed Ordinance 24-51, and such motion was seconded by Justice Knight. Counsel Murphy read Proposed Ordinance 24-51 by title only. After discussion, Judge Dodson called for a vote by roll call for Proposed Ordinance 24-51. The roll was called and Proposed Ordinance 24-51 passed with a vote of 13-0.

The Court discussed Proposed Ordinance 24-52. This is an appropriation Ordinance to establish the annual operating budget for calendar year 2025, and to declare an emergency. Justice Tyler made a motion to accept Proposed Ordinance 24-52, and such motion was seconded by Justice Knight. After discussion, Judge Dodson called for a vote by roll call for Proposed Ordinance 24-52 with amendments. The roll was called and Proposed Ordinance 24-52 passed with a vote of 13-0.

The Court discussed Proposed Ordinance 24-53. This is an appropriation Ordinance to repeal Faulkner County Ordinance 21-13 (June 23, 2021), and to declare an emergency. Justice Tyler made a motion to accept Proposed Ordinance 24-53, and such motion was seconded by Justice Knight. Counsel Murphy read Proposed Ordinance 24-53 by title only. After discussion, Judge Dodson called for a vote by roll call for Proposed Ordinance 24-53. The roll was called and Proposed Ordinance 24-53 passed with a vote of 13-0.
