IV. PROGRAM	<p>Charles Prout and Steven Craig of the Conway Fire Department Hazmat Team were today's presenters. Their hazmat team makes runs inside the city limits, in the county and even sometimes calls in other parts of the state. They don't do remediation but will assist in setting up an operations area.</p> <p>The hazmat team has many different types of equipment ranging from personal protective gear, litmus paper and machines that can identify the family class of a particular substance. They can test for bases or acids and radiation, oxygen levels, flammability, carbon monoxide and even sewer gases. They have access to the help of Conway Fire Department Bomb Squad should the need arise.</p> <p>During large events such as the fair parade, Toad Suck and UCA football games they can do air monitoring to keep the crowds safe.</p> <p>There are many classes available to responders that cover basic hazmat to very detailed hazmat chemistry.</p> <p>Our area is seeing more and more fentanyl calls, which the hazmat team sometimes responds to in order to test types of drugs.</p> <p>If needed, the Conway Hazmat Team will help train local hospitals, responders and other groups that might need training.</p>	Charles Prout & Steven Craig
