

PROPOSED ORDINANCE 24-44

Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas. An Ordinance to be entitled: An appropriation Ordinance to amend and supplement Faulkner County Ordinance 23-36 as a one-time pay increase of \$300.00 for all full-time employees and \$150.00 for part-time employees, to be paid with a payroll date of November 21, 2024, and to declare an emergency.
